Minutes

1st Vice Chair John Lynch opened the meeting.

I. <u>Elected Officials (3-4 minutes per speaker)</u>

Michelle Booker; Congressman Espaillat:

Good turnout for the Tuskegee Airmen Post Office meeting. A copy of the public law for the renaming of 99 MaCombs place was distributed. Friday at 4pm Congressman Espaillat is hosting an event open to the public. This is between CUNY and SUNY; administration of higher education of the Dominican Republic. This is to ensure opportunities for Dominican students enrolled at the University.

Today (12/05) Congressman Espaillat joined Governor Cuomo and other elected officials at a labor rally protesting Charter and Spectrum. 1800+ workers and technicians in union and labor talks for over a year and last Friday Spectrum walked away from the table. The fight is to make sure the union workers have a healthy negotiating contract with their employers.

12/01 Congressman Espaillat recognized World AIDS Day. There are over 1 million people in the US living with AIDS. This is a health crisis abroad and here in the US which is being addressed along with the funding for this crisis.

Congressman Espaillat is working Kristen, Shumer, Vazquez and Nadler to announce new legislation to honor a woman who worked in the revolutionary war.

Congressman Espaillat was elected to be the new Whip for the Hispanic Caucus.

Atheena Moore; Manhattan Boro President Gail Brewer.

Was away last month on behalf of the MBPO.

Congratulated newly elected/re-elected officers in last month's election. Email was sent related to the Charter and term limits on community board members. This law takes place next April. For community board members whose appointments expire in 2019; it is hoped everyone will apply for reappointment. If you are not sure when your appointment expires, please contact the Manhattan Boro President's office. Can apply online and paper applications are downloadable as well.

Diaper drive with the food bank and Girl Scouts Greater New York. Sizes 3-6, 4 & 5 are the most needed for working families. Drop off at 125th street or Center Street. If use Amazon can order directly from the food banks and have it sent directly to the warehouse. The money will go to tech improvement, broadband infrastructure.

NYC Capital funds can not be used for non network computers like tablets; the MBPO wants to make sure the WiFi capacity will work so the students can use the devices.

The Mayor's Office released the scope for the borough based jail for the Rikers relocation which will be 125 White street aka The Tombs. Rikers Task force meeting next week at the MBPO to continue working with stakeholders, elected officials and residents to ensure a successful closure of Rikers Island.

Northern Manhattan Hospital is hosting an ongoing series for New York City housing and federal finance; 12/11 2-5pm to be conducted simultaneously with the Department of Aging's Blood pressure screening.

On January 5th the number 1 train will bypass the 168th street station for one year. The MTA will provide enhanced M5 bus services, the MBPO continues to advocate for free shuttle service between 157th and 158th but

as of now the MBPO continues to express disappointment the MTA has not made its services fully accessible who need a free trip.

The MBPO is working with WRATH to host healthy relationship workshops, the 2nd Wednesday of each month through June; 6pm. The first workshop is at the Northern Manhattan Office; 12/12. A global initiative on activism to prevent gender based violence.

Also hosting discussions for local input, stabilize and revitalize green space and surrounding areas.

The MBPO is cosponsoring the tree lighting on December 7th.

The MBPO is responding to no heat, hot water complaints and gas outtages. Ongoing efforts to work with the residents for restoration of services.

Working with New York City Parks on the PS 125 community visioning.

Hosting an upcoming community workshop to discuss major improvements to the schoolyard baseball field.

Thanked everyone who attended the Harlem Lights festival and the 600 who attended the toy drive.

E. District Manager's Report - Shatic Mitchell

Board member packets are late this month due to postponed or cancelled committee meetings; minutes were not received.

The 2020 district needs statement was submitted 2nd week of November, CB10 was given an extension; hopefully we will be able to submit on time next year.

November 19th; with the Harlem 125th Street BID celebrated the Harlem Lights on 125th Street.

Thanks to George Harrell who is the new Chair for Arts and Culture subcommittee of entertainment and programming for his assistance in making sure the event was a success with one week notice. FYI; he is a road manager, tour manager for a lot of R&B stars; he is a tremendous asset. We were able to pull this off after the surprise snowstorm.

Thanks to Michael Downie for a portion of the budget to purchase subway sandwiches to feed the community.

On November 27th with board member dr. Hazel dukes met with the Commissioner of media and entertainment from the Mayor's office.

November 30th with transportation committee Chair Raquel Vasquez met with the newly appointed Commissioner from the department of transportation to discuss the city bike expansion program, the effect on parking and how to save parking spaces by putting the bike racks on the sidewalks. Many churches oppose the bike lanes, many people double park on Sunday without getting tickets but with a bike lane this could change.

For those opposed to bike lanes; statistics were provided:

KSI=Killed Severely Injured resulting in crashes with motor vehicles was analyzed from 1996 to 2016. Data shows the more cyclists on the road, the safer it is with a drop in fatalities, with the conclusion it is better to have bike lanes for the community.

Acknowledged board member Leevert Holmes and his assistance on the garbage pile up outside of a playground.

F. Committee Reports/Announcements (1-2 minutes per Speaker):
Transportation committee; R. Vazquez, will have a meeting on bike lanes.
CB 10 board member K. Horry stated all stakeholders should be at "the table" regarding city bikes.

Ihope Academy on 116th and Lenox; the students were not able to safely exit the school bus. CB10 board member R. Vazquez thanked C. Curry for advocacy efforts along with the committee and the Chair for supporting the effort in assisting the school.

City Bike expansion; everyone should attend the transportation committee meetings.

Board members were cautioned on avoiding the appearance of supporting a program without the input of every board member and the chance to vote on an issue. The board has not taken a position on the bike lane expansion.

Housing Committee; C. Powell, acknowledged the residents of 123 West 112th were in the TIL Program and were removed as a result of HPD. Jason Wu; Legal Aid Society filed an article 78 petition on the issue. "we support the residents because these are long term residents; 30-40 years going from potential co-op owners to people from the outside taking over due to regulations by HPD."

Benjamin are going to meet with Anne Marie Hendrickson.

CB10 is opposed to HPD; re: TIL program.
