## **TRANSPORTATION PRESENTATIONS**

NYC DOT liaison Lyle Blackwood gave a presentation updating the committee about proposed designated loading zones during daylight hours at six locations within CB 10, as well as updating the Committee regarding the status of the sidewalk on West 117<sup>th</sup> Street. The committee did unanimously approve a letter of response from the Committee to the DOT commissioner regarding the lack of local community input in the implementation of the DOT car sharing program and loss of local public parking programs.
