# HOUSING COMMITTEE MEETING MINUTES

#### 2. Welcome & Presentations by Elected Officials (Two Minute Limit):

- ➤ Minah Whyte Community Liaison of the office of the Manhattan Borough President was in attendance and introduced her associate Eric Cuello, Deputy Director of Community Affairs for the Manhattan Borough President who was also on the call but did not offer comments.

- What is NYCHA Preservation Trust? Educational Forum
