- c. Dr. Malcolm Punter, President & CEO Harlem Congregations for Community Improvement (HCCI - Update on the Bradhurst Brownfield Development Study
  - i. Supported by Department of State and awarded to HCCI
  - ii. To determine how to identify -strategic sites for development either in real estate or environmental deficient areas
  - Based on a larger federal SuperFund legislation- provides state governments with funding to clean up sites / vacant land that has been contaminated by petroleum or other toxic waste
  - iv. Harlem- 130th and up has environmental damage from
  - v. Underground streams
    - 1. Grant is to study historical 145th between lenox and 5th is a brownfield site
      - a. Tanks leak
      - b. Susceptible to earthquakes
    - 2. 3rd iteration
      - a. This is a continuing conversation and dialogue and welcome futur
    - 3. Sites may be publicly or privately owned
    - 4. How community wants to see their community developed

  - Examples- 1. Film production company on 146 between 8th and 7th was abandoned for 30 years and the film proofs that had been stored there were toxic and seeped into the soil
    - i. State funding was leveraged to clean up the toxins from the site

    West 146tth street now home to 65 seniors
