- Question raised and discussion held to add an additional resolve pertaining to the DAMP Tax. The committee agrees and it will be added to the Resolution.
- HDFC owners were allowed to *opine* on the proposed resolution and asked to add input. Reference was made to the secition of the proposed Resolution which objects to the portion of the proposed Regulatory Agreement which objects to its "one size does not fit all HDFCs" characterization.
