MEETING MINUTES

1. Welcome/Introductions

2. Discussion Items:

- a. CB10 Meeting with LPC on 12/19/17
 - i. LPC is not considering any of the other recommendations that CB10 and Save Harlem Now. They said that the Commissioners have to make recommendations amongst themselves and do not accept recommendations from the public or community boards.
 - ii. We need to schedule a meeting with Council Member Perkins and other elected officials on the importance of historic preservation and landmarking in CB10.
- b. Resolution on the Harlem Bike Network in CB10, CB9, CB11
 - i. We reviewed a draft resolution that Raquel prepared. We will edit and review the updated draft resolution in January and February 2018.
 - ii. Other community boards anticipate voting on the Harlem Bike Network in February 2018.
 - iii. We will bring the final resolution to Executive Committee in February and anticipate a full board vote in March 2018.
 - iv. The Committee still expressed issues with the community outreach conducted by DOT. DOT should conduct targeted outreach to senior centers and groups, schools, business associations, precinct council meetings, NYCHA developments, CEC meetings, etc. The Committee will share with DOT a full list of how the agency can improve targeted outreach in CB10.

- v. The Committee suggested co-sponsoring a community event with CB10 & DOT regarding all transportation-related updates that DOT has to share with our community. This will include the status of Citibike installations and usage, recent street pavements, Harlem Bike Network, bike safety, and bike safety materials and giveaways.
 - vi. The Committee will provide DOT with an outline of the event format.
- c. Street co-namings: CM Perkins' Process
- i. We reviewed the process that CM Perkins' office shared with CB10. We have an issue with only 2-4 street co-namings per year since CB10 shared approximately 12 resolutions with CM Perkins' office in 2016 alone.
 - ii. We need to schedule a meeting with CM Perkins' office to discuss this process and figure out a way to proceed on the remaining street co-namings in a timely manner.
- d. Faith-based preservation and development conference
- i. Will be held on January 24th
