- Small Business Services- (Eric Parker) Outreach team. Mr. Parker reported SBS will be providing relief for business that did not receive assistance in the first two rounds of PPP. SBS is also offering technical support to small businesses and commercial lease assistance. All services are remote. Commissioner of SBS is working to put a 5-point plan for all communities in NYC.
