Meeting Commenced at 6:00 pm Public Session

Introductions by Chairman Perry: Hon. Perry praised Inspector Harrison for their Precincts Community Counsel meetings. Mr. Perry continued by saying that both the 32 and 38 Precincts have an open door policy and the community should attend their meetings. Hon. Perry also welcomed the new board members into roles as board members.

Community First: Honorable Henrietta Lyle called upon:
