Community First: Hon. Keith Taylor called upon:

Elected Officials (representatives)

Ms. Saxon of the Manhattan Borough President's Office welcomed the new Board members to CB10. She also spoke about "pink slime" in meat and announced that Mr. Stringer has fought to not have any more "pink slime" school meat. This will begin school year 2012.

Mr. Horton of Congressman C. Rangel's office announced an event for small businesses on April 10th 2012 at the State office Building.

Famed Konneh from the Man. District Attorney's Office s stated the basketball program is going very well and will branch out to the Jefferson Projects. Also they are continuing to look for internships for the DA's Intern Program.

State Senator Bill Perkins announced that the state budget passed early this year. He is currently working on the Dream Act. Sen. Perkins however, was not keen with the changes of the NYS pension system; including a Tier 6 was not a good move. Moreover the redistricting was not easily receptive. A 63rd seat was created. Finally the Trevon Martin situation is a hot topic amongst communities of color.
