Election Committee Report Charles Johnson

Presentation of Voting Items

<u>Ratification of By Laws – By Laws Task Force (Vote was unanimous in support of the change) Vote</u>

One change to by laws around terms of membership. Adding what the City Charter did last year in adding term limits of 4 consecutive terms or 8 years.

Barbara Nelson mentioned that she thought that we were adding language that tells members how they would be held accountable if they do not attend board meetings. Marquis mentioned that there is language in the current by laws. Also that there was a call for changes in January and there were no changes suggested. Board member Nelson

mentioned that she had a discussion with District Manager Mitchell. Dr. Dukes mentioned that the conversation should not be with the District Manager but to the Task Force Committee.

Board member Horrey asked if this was an addition or change. Marquis Harrison said it is an addition because there were no term limits before.
