> Manhattan Community Board 10 General Board Meeting Minutes January 8, 2020

Isma Pesson – Art Gallery Update – Community artists have been denied use of the Art Gallery here on the second floor of the Harlem State Office Building. Agreement reached on December 12<sup>th</sup>. There will be an exhibit from Governors office that has been in storage for the past 20 or 30 years. Artist will be able to be a part of the exhibit for Black History month. Ten to fifteen pieces of art by community artists will be exhibited. The exhibit grand opening will take place the first or second week of February.

Shawn Hill – Co founders Greater Harlem coalition. Comprises over fifty Harlem and East Harlem Block Associations, Faith Based organizations and small businesses. Main focus is the over saturation in our community of drug treatment facilities. On Feb 5 at the General Board meeting they will present data from the city and state.

Stephanie McGraw – from WARM. Located on 140<sup>th</sup> Street and they have monthly meetings. They need space to see clients. They need a PR person, need a budget person and they need funds to operate.

## **NYC Parks Community Gardens - Karen Horry**

Resolution for the Community Gardeners to have two clauses removed from the licensing that is being required. License must be renewed every 4 years it is now very lengthy. The clauses that the gardeners feel are unfair are in paragraph 7D which reads the license is terminable at will by the commissioner at his/her discretion at any time with 60 days written notice and licensee shall

have no recourse, and the second clause states waiver of trial by juror. The committee voted unanimously to support the gardeners.
