- Republican control of NYS Senate following elections will have negative impact on expiring housing laws.

- Participated in numerous events marking Domestic Violence Awareness Month
- Launching, with the Mayor and Police Commissioner, NYPD Mobility Initiative. \$160 million from asset forfeiture funds will be used to equip police with electronic devices to allow them to access data and run checks from the field.
