## PROPOSED AMENDMENT NO. 1

To Amend Article II (BOARD MEETINGS), Section titled MEETING NOTICE; AGENDA; PUBLIC SESSION; BUSINESS SESSION, Section 2 ("Agenda").

Section 2 ("Agenda") presently reads:

"Written agendas must be prepared and distributed for all meetings, whether regular, special or emergency. The agenda shall be drafted by the Chairperson of the Board with the assistance of the Executive Committee and District Manager at least three (3) days before each full Board meeting. The agenda shall follow the order specified below and shall include the Chairperson's and the borough president's suggestions of business to be transacted at the meeting. The opening of the meeting and adoption of the agenda shall be included in the agenda. An agenda shall consist of the following."

Proposed Amendment No. 1 would amend the sentence "The agenda shall be drafted by the Chairperson of the Board with the assistance of the Executive Committee and District Manager" to read:

"The agenda shall be drafted by the Chairperson of the Board with the assistance of the District Manager, and the assistance and approval of the Executive Committee."

## PROPOSED BYLAW AMENDMENT NO. 2

Amendment No. 2 would remove the Board Chairperson's authority to appoint, suspend or remove the Chairs of the various committees and the Parliamentarian and give the Executive Cabinet the authority to select Committee Chairs and the Board's Parliamentarian. The Board Chair would retain the authority to appoint the members of each Committee. The specific bylaw changes would be as follows:

a. Article III, DUTIES AND RESPONSIBILITIES OF OFFICERS, Section 1 ("Duties of the Chairperson") presently reads "To appoint, suspend or remove members and chairpersons of the committees of the Board."

This amendment would remove the phrase "suspend or remove" and the word "chairpersons" so that the amended Section would read: "To appoint members of the committees of the Board."

b. Article V (COMMITTEES), Section 3 titled "Membership and Procedures", currently provides:

"c. Standing Committee chairpersons are accountable to the Chairperson and shall submit to the Executive Committee accurate records of standing committee meetings as follows:

- i. Board members and public attendance for each committee meeting;
- ii. Resolutions adopted, with a tally of the vote."

As amended 3(c) would provide as follows:

"c. Chairperson's of Board Committees, Task Forces, and the Boards Parliamentarian serve the full Board, and shall be appointed, suspended or removed, by a vote of the Executive Cabinet. The Chairperson can make recommendations about selection of Committee Chairpersons. Committee Chairpersons shall make monthly reports at Executive Committee meetings and periodic, or as needed reports to the full Board."

### PROPOSED AMENDMENT NO. 3

Amendment No. 3 amends several bylaw provisions in order to change the commencement dates of Officer terms from July 1<sup>st</sup> to January 1<sup>st</sup> and the termination dates from June 30<sup>th</sup> to December 31<sup>st</sup>. The length of Officer terms would remain as two years. The dates of elections would be change from June to November and the dates for nominations would be adjusted accordingly. The following specific bylaw changes would be made:

a. Article III, Section 2 ("Terms of Office") presently reads "Each officer shall serve for a two (2) year period beginning on July 1 following the election of officers and terminate on June 30 of the second following year." **As amended, it would read: "Each officer shall serve for a two (2) year period beginning on January 1 following the election of officers and terminate on December 31 of the second following year."**

b. Article IV (ELECTION OF OFFICERS), Section titled "ELECTIONS" presently provides that "At the Regular Board Meeting in June, pursuant to a written notice to each Board Member, an election will be held for the offices of the Board." **As amended, this Section would read: "At the Regular Board Meeting in the November before the officers' terms expire, pursuant to a written notice to each Board Member, an election will be held for the offices of the Board."**

c. Article IV (ELECTION OF OFFICERS), Section titled "NOMINATIONS", Section 1, currently provides:

"1. At the regular May meeting of the year which requires election, the Board's Nominating Committee shall make its report. At such meeting, members may offer additional nominees from the floor. No member of the Board may be a candidate for more than one office during an election.

2. Candidates prepared to accept nominations must deliver a written statement to the Secretary at the May meeting.

3. There shall be no further nominations from the floor at the June meeting unless a position is vacant."

**As amended, this Section would read:**

**"1. At the regular October meeting of the year which requires election, the Board's Nominating Committee shall make its report. At such meeting, members may offer additional nominees from the floor. No member of the Board may be a candidate for more than one office during an election.**

**2. Candidates prepared to accept nominations must deliver a written statement to the Secretary at the October meeting.**

**3. There shall be no further nominations from the floor at the November meeting unless a position is vacant."**

#### PROPOSED AMENDMENT NO. 4

This Amendment would remove from the Board Chairperson the authority to appoint the Nominating Committee. This amendment would require the Board to elect the Nominating Committee at the September meeting of each year in which Officer elections are held.

Article IV (ELECTION OF OFFICERS), Section titled "NOMINATING COMMITTEE" currently provides:

- "1. A Nominating Committee consisting of five (5) members shall be announced at the regular Board meeting in April of every other year which requires elections. The Nominating Committee shall be selected by the Chairperson of the Board, who shall also designate the Chairperson of the Nominating Committee. Members of the Nominating Committee are ineligible for candidacy for any office.
2. The Nominating Committee shall meet as often as necessary thereafter in order to report to the Board at its May meeting of every other year which requires election of one or more candidates for each of the office of Chairperson, First Vice-Chairperson, Second Vice-Chairperson, Secretary, Assistant Secretary and Treasurer."

As amended this Section would read:

- "1. A Nominating Committee consisting of five (5) members shall be elected by the Board at the regular Board meeting in September of every other year which requires elections. The members of the Nominating Committee shall select its Chairperson. Members of the Nominating Committee are ineligible for candidacy for any office.
2. The Nominating Committee shall meet as often as necessary thereafter in order to report to the Board at its October meeting of every other year which requires election of one or more candidates for each of the office of Chairperson, First Vice-Chairperson, Second Vice-Chairperson, Secretary, Assistant Secretary and Treasurer."

## PROPOSED AMENDMENT NO. 5

To Amend Article III, Section 1(b).

Section 1(b) presently reads "The Board shall elect officers of the Board, however, the office of Parliamentarian is an appointed position and such person may or may not be a member of the Board."

Proposed Bylaw Amendment No. 5 would remove the phrase "and such person may or may not be a member of the Board" at the end of the Section.

As amended, the Section would read: "The Board shall elect officers of the Board; however, the office of Parliamentarian is an appointed position."

## PROPOSED AMENDMENT NO. 6

To Amend Article III, by adding a new Section 4 to be titled "Vacancy in other Officer Positions."

The new Section 4 would read "Should a vacancy occur (death, disqualification, removal or resignation) with respect to any office other than the office of the Chairperson, a special election will be held within sixty (60) days to elect a new officer for such vacated position."

**Note:** The current bylaws do not contain a provision addressing a vacancy in any office other than Chairperson. The current process for filling a vacancy in the Chairperson office (First Vice Chair becoming the Chairperson, Second Vice Chair becoming First Vice Chair and a special election held to elect a new Second Vice Chair) would remain unchanged.

## PROPOSED AMENDMENT NO. 7

To Amend Article III, Section 4 ("Rotation of Chairpersons").

This Section presently reads "To provide the greatest opportunity for service by each member, no Chairperson shall serve for more than two (2) consecutive terms except by a majority vote of the Board."

Proposed Amendment No. 7 would remove the phrase "except by a majority vote of the Board" at the end of the Section.

As amended, the Section would read: "To provide the greatest opportunity for service by each member, no Chairperson shall serve for more than two (2) consecutive terms."

## PROPOSED AMENDMENT NO. 8

To Amend Article III, DUTIES AND RESPONSIBILITIES OF OFFICERS, Section 1 (“Duties of the Chairperson”)

Section 1(n) of the “Duties of the Chairperson” presently reads “Supervision and management of the District Manager and the District Office.”

**Proposed Bylaw Amendment No. 8 would amend Section 1(n) to read: “To supervise the day-to-day operations of the District Office, and to consult work with the Personnel Committee with respect to the Personnel Committee’s oversight of personnel issues and other duties of the Personnel Committee as set forth in Article 5 hereof.”**

**Note:** Proposed Bylaw Amendment No. 9 would create a new Personnel Committee that would oversee management of the District Manager and the District Office.

## PROPOSED BYLAW AMENDMENT NO. 9

To Amend Article V (COMMITTEES) to create a new committee to be known as the "Personnel Committee."

The composition and duties of the new Personnel Committee would be as follows:

### 1. In General

a. The Personnel Committee shall be made up of the officers of the Board and four members of the Board, elected by the Board, every two years, at its January meeting following the election of officers.

### 2. Responsibilities and Powers

a. The Personnel Committee shall determine the qualifications for the selection of staff members for the District Office, their duties and the development of personnel policies and benefits.

b. The members of the Personnel Committee shall elect a Chairperson of the Personnel Committee. In making this selection, the Personnel committee shall give weight and consideration where possible to candidates who possess professional experience in relevant disciplines such as Human Resources, Union, and employment regulations, procedures, and laws.

c. The Chairperson of the Personnel Committee shall be responsible for all personnel issues regarding the District Manager and other District Office staff. He/She should report to and work closely with the Chairperson of the Board and the other members of the Personnel Committee.

d. The Personnel Committee shall be responsible for the development and creation of evaluation tools, methodology and the annual staff evaluations/reviews.

e. The Personnel Committee shall prepare periodic, or as needed reports to the Board Chairperson and the full Board.

## PROPOSED BYLAW AMENDMENT NO. 10

To Amend Article VI (DISTRICT MANAGER AND STAFF) with respect to the duties and responsibilities of the District Manager.

Assuming that the Board votes in favor of establishing a Personnel Committee, Proposed Bylaw Amendment No. 17 would amend the following duties and responsibilities of the District Manager to provide for oversight by the Personnel Committee as opposed to the Board Chairperson and/or Executive Cabinet and Executive Committee:

- The District Manager shall be responsible for the administrative functions of the District Office with authority to direct and supervise the activities of any employees and shall be present at the Executive Cabinet, Executive Committee and General Board meetings. Such responsibilities shall include the hiring, firing and disciplinary actions of all staff in consultation with the **Chairperson of the Personnel Committee**.
- Report to the Board on the functioning of the District Office in accordance with procedures and guidelines established by the **Personnel Committee** and the Board.
- Present to the **Personnel Committee**, for its review, the projected annual budget and bi-monthly financial and program reports of the activities of the District Office. The **Personnel Committee** shall present such report to the Executive Committee.
- Perform such other lawful duties as are assigned by the **Personnel Committee**. No Board member shall interfere with the District Manager or any staff in the District Office.

## PROPOSED BYLAW AMENDMENT NO. 11

To Amend Article III, OFFICERS; TERMS OF OFFICE; VACANCY IN THE CHAIR;  
ROTATION OF CHAIRPERSONS, to add a new Section 5 to read as follows:

### 5. No Confidence Votes.

Any member may express, in confidence, a claim of "no confidence" with respect to any Board Officer to a five-member panel which shall consist of the Board's most recent Nominating Committee. If the panel determines that there is no justification for the claim of "no confidence", the claim shall proceed no further. If, however, the panel determines that there is justification for the claim of "no confidence", the panel shall present the claim to the Board at the next General Board Meeting at least 30 days after the presentation of the claim. The Board shall vote on the "no confidence" claim at that meeting. A statement of "no confidence" must be approved by a majority of Board members present and voting at a said General Board Meeting.

## PROPOSED BYLAW AMENDMENT NO. 12

To Amend Article III, OFFICERS; TERMS OF OFFICE; VACANCY IN THE CHAIR; ROTATION OF CHAIRPERSONS, to add a new Section 6 to read as follows:

### 6. Removal of Officers

Any Officer may be removed "for cause" as described herein. An officer removal proceeding may be instituted by a vote of a majority of the Executive Committee or by a vote of a majority of Board members present and voting at a regular General Board Meeting. Upon such approval of either the Executive Committee or the Board, the Officer in question shall be presented with a written statement of the alleged cause for removal. The bases for removal for cause shall include but isn't limited to:

a. A material failure to carry out the duties and responsibilities of the office as set forth in these bylaws.

b. Ten (10) instances within a six (6) month period of unexcused nonattendance at General Board Meetings and/or Executive Committee Meetings, Executive Cabinet Meetings and Personnel Committee meetings.

c. The use of profanity or threats and/or engaging in physical confrontation with another board member or the community at large in full Board and/or committee meeting.

d. The Officer's failure to reveal material conflicts of interest of which the Officer is aware with respect to matters considered by the Board.

Due Process. The Officer in question shall be entitled to respond in writing within thirty (30) days of presentation of the written charge. The Executive Committee shall, within sixty (60) days after receiving the response, conduct a hearing on the charges and present a report to the full Board. At the next General Board Meeting following the presentation of said report, the Board shall vote on whether or not to remove the Officer. The Officer shall have the right to be represented by an attorney at any stage of the proceedings and may summon witnesses on his/her behalf at the hearing. In the event that this process results in removal of the Officer, barring any other language in the by-laws regarding succession, an election must be held within 30 days to fill the resulting vacancy.


