Community Board 10: Chairman Franc Perry's Report

- □ Chair Perry wants to join all organizations to come together in a joint taskforce stop the Gun Violence amongst teens in the Central Harlem Community.
- □ Chair Perry addressed the issue of the cul-de-sac amid St. Nicholas Houses. He stated that the project was done surreptitiously. Consequently, CB10 composed a resolution regarding the disposition of public space within the St. Nicholas Houses Complex. The resolution sparked much debate and a meeting with the Council members questioned NYCHA extensively of their plans for St. Nicholas Houses and future endeavors.
- □ In March 2011, a forum will commence addressing the issue of Women in Business in Harlem. Details will be announced.
- □ Chair Perry the passing of Leon Wynter, a community advocate and friend. Sadye Vassil has resigned from the Board and the Board thanks her for her diligent energy and work towards the community. We wish her well in her future endeavors.

Paimaan Lodhi District Manager's Report

- NYCHA's section 18 approval process for the disposition of land is vague, and CB 10 has asked both NYCHA and the City Council to reform the process to include more meaningful community engagement. The Board received overwhelming support from other Community Boards and the MBPO on this. Both CB 10 and the MBPO testified at a City Council Hearing, and asked that NYCHA reform its approval process, one that requires Community Board approval for the disposition of any NYCHA property.
- □ At the Landmarks Committee meeting, Mount Morris Park Community Improvement Association presented a preliminary proposal on the expansion of the Mount Morris Park Historic District. The Committee is also working on a letter to LPC Commissioner Tierney detailing several complaints the Board has with landmarks related issues in our District.
- □ Finally, please follow up with the MBPO if you have not heard back about your Community Board application.
