Liquor License New Applications:

The Park Wine Bar, 2080 Frederick Douglass Blvd. Mr. Lewis Tucker-Farrugia from The Park Wine Bar presented. Potential issues regarding noise, garbage and public safety were identified and deliberated. Liquor license application was recommended for approval with a unanimous vote of 12-yes, 0-no, and 0-abstentions.

Notar Lounge, 288 Lenox Avenue. Mr. Richard M. Notar from Notar Lounge presented. An issue regarding future use of the Lenox Lounge trademark was expressed by a member of the community and deliberated, with Mr. Notar stating that he would not use the Lenox Lounge trademark name for his new establishment. Liquor license application was recommended for approval with a vote of 7-yes, 4-no, and 1-abstention.

Blue Monk, 17 West 125th Street. Mr. Steven Stadmeyer from Blue Monk presented. Potential issues regarding noise and public safety were identified and deliberated. Liquor license application was recommended for approval with a vote of 10-yes, 1-no, and 1-abstention.

ACP 111 Rest Corp., 1838 Seventh Avenue. Mr. Marc Bernstein from Suzy-Q's Bar-B-Q presented. No adverse issues identified. Liquor license application was recommended for approval with a vote of 12-yes, 0-no, and 0-abstentions.

Shell's Bistro, 2150 Fifth Avenue. Mr. Andrew N. Shell from Shell's Bistro presented. Potential issue regarding noise was identified and deliberated. Liquor license application was not recommended for approval with a vote of 5-yes, 6-no, and 1-abstention.
