## Saint Nicholas Mircle Garden

Amanda Mouzon, Dara Ross and Landon Westbrook gave a presentation about a community garden called Saint Nicholas Miracle Garden located at 330 Saint Nicholas Avenue between 126th and 127th Streets. The goal of the garden is to create an urban garden which will be a huge environmental asset for the neighborhood. They will promote a sharing of resources that

allows neighbors to grow healthy food or plants. Green Thumb Deputy Director Roland Chouloute reported the land can be utilized for a neighborhood garden. Amanda Mouzon requested a letter of support from Community Board #10 for the Community garden.

## **Street Co-Naming Officer Philip Cardillo**

Inspector Rodney Harrison 32 PCT., presented the street co-naming on behalf of the NYPD and fallen Police Officer Philip Cardillo. In 1972, PO Cardillo was injured inside the Mosque at 116th Street and later died of his injuries. No one was officially charged with the incident, and the investigator is still open.

Inspector Harrison presented the street co-naming. Location: 123rd Street near the 28th Precinct, "Philip Cardillo Way". After Inspector Harrison's presentation, the floor was opened to the community. The members of the Mosque and the community opposed the street co-naming for many reasons. There were many questions about why this issue was brought to the CB10 so many years after the incident. Inspector Harrison remarked that they (NYPD) felt the need to honor PO Cardillo. A question that was heard many times during the presentation was how the NYPD can honor PO Cardillo in a way that did not involve a street co-naming.

The outcome of the Hearing - The Imams of the Mosque and the NYPD will meet to discuss this issue and return to CB10 with possible solutions to the street co-naming request.
