At the General Meeting on Tuesday, December 19th, 2017, with a vote of 31 in favor, 8 opposed, 0 abstentions, 0 not voting, Community Board 12 Manhattan, passed a resolution of **Objection** to the New York State Liquor Authority application for an alteration to its On-Premises Liquor License for La Nueva Potencia Corp. dba Zoe Restaurant & Bar Lounge; and

Whereas, La Nueva Potencia Corp. dba Zoe Restaurant & Bar Lounge – 1559 St. Nicholas Ave (corner of w 188th St) 10040, license # 1281635, has duly notified Community Board 12 Manhattan of its intention to file an application for an alteration to its On-Premises Liquor License; and

Whereas, the Licensing Committee met on December 13th, 2017 to hear comments from the community and the precinct regarding this establishment's request to change the bar closing time to 4AM and add karaoke and DJ to its Method of Operation; and

Whereas, the restaurant is on the street level of a five (5) story Residential and Commercial building with 38 residential units; and

Whereas, there was some inconsistency between the information given to Community Board 12 in November 2017, and that, given in December 2017 Questionnaire. In November, the applicant stated that there are 43 tables, 87 chairs and 12 bar stools while in December, the applicant indicated that there are 10 tables, 65 chairs, and 12 bar stools. Further, the total legal capacity stated in the Community Board application submitted in November was 100 persons and in December, it was 74 persons.

Whereas, based on the information given to the Community Board 12 Manhattan in November, the potential total number of persons seated is 97 plus 8 employees exceed the total legal number of persons by 5 persons. And in December applications, the total number of persons seated is 77 persons plus 6 employees exceed the total legal number of persons by 8 persons; and

Whereas, the requested hours of operation 11AM to 1AM seven (7) days a week; and

Whereas, per the applicant, the establishment's Method of Operation includes Juke Box, IPod, Internet and recoded Music only; and

Whereas, community members, some who live above the establishment, complained about excessive noise. But, One community member that lives above the establishment complained that his brother who also lives next door suffers from schizophrenia (medical documents are available if needed). He complained via 311 and tried to talk to the owner about the loud music and noise emitting from the establishment for about two years to no avail; and

Whereas, although not under the current Method of Operation, the venue operates with a DJ and advertises karaoke prior to receiving an approval from the New York State Liquor Authority. Complaints were received from community members about DJ and karaoke nights already playing at the establishment although not on the establishment's method of operation; and

Whereas, adding a DJ and karaoke raises a concern by the 34th Precinct that this location will turn in a club. The Precinct asked the owner to address several issues and chose not give eight (8) summonses to the establishment as a courtesy since it was a newly opened business. The 34th Precinct asked the owner to run the establishment per the SLA license; and

Whereas, the 34th Precinct cannot support this application at this time; therefore, be it

Resolved, that Community Board 12 Manhattan **Objects** to the New York State Liquor Authority Alteration of the On- Premises Liquor License for La Nueva Potencia Corp. dba Zoe Restaurant & Bar.

The concern is that this establishment will pick up Cliff's clientele and with that a continuation of the same problems; and

Whereas, When asked by the 34th Precinct, the representative of the establishment, Miguel Acosta stated that Cliff's owner is a consultant for Taboga's decoration, food, etc. therefore, be it

Resolved, that Community Board 12 Manhattan **Objects** to the New York State Liquor Authority Change of Method of Operation for Eat @ Sherman Creek Inc. dba Taboga.
