<u>Call to Order</u>: Chair Richard Lewis calls the meeting to order at 6:44 pm. He welcomes everyone.

Quorum is attained. Agenda is adopted. Reflecting the fact that the June minutes only had the odd pages, and the Sept. minutes were missing, Chair Liz Ritter recommended we move Minute adoption to next month's General Meeting. Seconded/approved by Chairman Lewis

**Chairman's Report:** Richard Lewis' report covered the following topics:

On October 15<sup>th</sup>, he hosted a meeting of the Board to complete Capital and Expense budget rankings.

- He reviewed the work of the various committees especially the liquor license committee whose work requires at least 2-3 hours per month. There will be a meeting with the SLA to review what can be done to remedy the work load of this committee.
- He attended many meetings including those held by the Borough Board, UMEZ, Councilman Rodriguez/ State of the District, the EDC, etc.
- The new Community Associate who was hired in July is doing well and her performance will be evaluated shortly.
- He testified at the MTA Board's \$51 billion capital budget hearing regarding the community's' transit needs and the need for shuttle bus service while renovations are underway.
- He announced the formation of the Nominating Committee, chaired by Matt Levy and whose members include Mary Anderson, Robin Cruz, Cindy Matos and Omar Tejada.
- He continues to work with live streaming provides regarding the remaining work that needs to be done for the 6<sup>th</sup> floor conference room.

### District Manager's Report (6:55): Ebenezer Smith's report covered the following topics:

- CB #12, M Budget Ranking FY21 We worked very hard in the Budget Ranking preparation for Fiscal Year 2021in this month. We provided all the necessary materials for each committee for their committee ranking. We prepared the board's public hearing on budget ranking for FY21. This meeting was very successful. We have all ranking submitted by the participating board members for the final tabulation and submission to OMB and City Planning before the end of the month.
- The Broadway Bridge Rehabilitation Project This project still on hold. However, NYC DOT will be cleaning and working on the east sidewalk of the bridge from 7 am to 6 pm during this week. Similar work will be done on the west sidewalk next week.
- Proposed Traffic Pattern Change on Cabrini Blvd. The 34th Pct. has proposed a traffic pattern change on Cabrini Boulevard between West 190th Street and Margaret Corbin Plaza. The proposed change consists of changing the street operation from one way northbound to one way southbound. Additionally, the 34th Pct. is proposing to change west 190 street from Fort Washington Ave to Cabrini from two-way traffic to a one-way street traveling only east. The purpose of these proposed traffic pattern change is to alleviate the traffic condition caused by Success Academy during the drop-off and pick up the students.
- Staff Evaluation I performed the 3-months evaluation to Ms. Shinelle Paniagua the new member of our staff as required by the resolution passed by this Board in June 2019.
- Q&A: Member Sara Fisher Requested a line-item budget should be sent out to all members. Answered, but confirming the report is sent to all the Members that participated in the Public Meeting
  - Chair Liz: Requested DM re-send the list to all Members. Denied by District Manager

#### **Government Officials**:

## **Gale Brewer, Manhattan Borough President** spoke about the following:

- The Charter Commission Ballot Initiatives are very important. Please review them & remember to vote.
- The Public Design Commission voted to approve the design and construction of the statue "Women Pioneers"- which will feature Sojourner Truth, Elizabeth Cady Stanton and Susan B.
  Anthony. The statue will be completed by summer 2020 in time for the 100<sup>th</sup> Anniversary of the 19<sup>th</sup> Amendment.
- On October 27<sup>th</sup>, the MBPO's office is hosting a Senior event from 12 pm to 3:00 pm at John Jay College.
- A Human Rights Law Workshop will be held in the Uptown Northern Manhattan office at 431
   West 135<sup>th</sup> Street on October 28<sup>th</sup> from 6:00 pm to 8:00 pm.
- The MBPO's budget unit is holding four informational workshops for Manhattan's public schools & not-for profits - P.S.'s – Nov. 6<sup>th</sup> & 13<sup>th</sup> from 4 pm to 6 pm and NFP's – Nov 7<sup>th</sup> and 14<sup>th</sup> from 4 pm to 6 pm.
- The MBPO's office has created a Religious Facilities Task Force that will meet for the first time on Monday, Nov 25<sup>th</sup> from 6 pm to 8 pm and LCR, 2 Center Street – 19<sup>th</sup> floor.

### Julie Menin, Director of the Census for NYS and Representative from the Federal Census Bureau

- Explained the importance of the Census with regard to Federal budget and fair representation
- Discussed the challenges from the trump administration on the "Citizenship Question"

- Promoted the Census being online, the travesty that 1/3 of NY'rs do not have broadband, and the need to be counted – NY had a 62% self-response rate (CB12 neighborhood was at 78%) last Census.
- Census begins March 12<sup>th</sup>!

### *Mark Levine – Councilman, District 7* reported the following:

- Promoted the training Councilman Levine's office is giving for working for the Census
- HDFC co-ops are facing a threat from a law that wasn't intended to impact them. Local law 64.
   Voiced support for making community buildings that were wrongly designated within the law, to fight for their exemptions
- Address electronic access issues regarding the data it produces and how it can be used for harassment, sold or stolen. Introducing legislation to severely restrict those liabilities

## Chris Nichol, Chief of Staff for the Office of Senator Robert Jackson:

- Nov. 4<sup>th</sup> and 12<sup>th</sup> Town Halls on the NY Health Act (w. Lead Sponsors of the Bills)
- Nov. 6 Climate Justice Summit to let people know about the new legislation (at the Yon Nagle)
- Promoted a pamphlet at the front on the Bills Senator Jackson is Sponsoring

### Carmen De La Rosa – Assemblywoman, District, District 72 reported the following:

- Promoted early voting and locations
- As a Manhattan delegation, they'll be attending NYCHA town halls (Nov. 28th first)
- Hyped legislative proposals she'll be introducing in the next session, but did not share what they
  were yet

### **Pubic Speakers Session:**

**Tina Jackson, WeAct.org, Inwood Healthy Homes Workshop** – Environmental Justice holding an event this Saturday at PS. IS from 11am – 1pm, last of 4 meetings for a planning project examining climate change's health impacts in Inwood. Promoted the event's "run of show" and the provided amenities.

**Elizabeth Ritter** – As a member of the Barack Obama Club, promoting a membership meeting tomorrow at "Word Up". Talking about 1) Early Voting 2) Ballot Propositions 3) NY Health Act. There's a hearing in the Bronx on the Health Act in the Bronx tomorrow at 10am.

**Nadine Racine** – Convincing to make Bill 1405-2019 a priority. The Bill is being taken-up in the City Council. The bill is ratifying a universal Restaurant Safety for Food Allergens

**Denely Lopez** – 1399 – to Amend the NY Charter section 20 Chapter 1 to push sustainability measures to combat climate change. Explained the peril NY is in, in regard to what Climate change has in store for us. This law will create a new agency to deal with NY's response to climate change

**Alberto Aquino** – **The Armory** is about to start its NY track season. If interested in coming to the Armory, and live in this community, you can go to a track meet for free b/w Nov. – April. Promoted track and health/wellness program, and the flyer being distributed in this meeting. Also announced the Youth Program after school (grades 2 – 8)

**Melissa Carreno** – Local law 16 75 (City Council) – advocating the amending of the code of NY in regard to distributing information on summer meals for children. Passing this will require the Dept. of Ed. to notify parents via direct mail on the summer meals program. Currently, the law is being supported by 6 other Council members.

**Teresa Montono, IG Restaurant Group** - Advocating for a Zumba environment that is healthy and free. 11-11 in Inwood is a community gathering place, not only for Zumba, but for so many other events. Item #17 on the agenda

**Ariela**— Applying for a license, Item 18 and 22. Here to advocate for his diner since this is the second time he's been in front of the board. Dyckman Houses have already approved his location.

**Rud Morales** – Speaking against Item 18 and 22. Due to personal reasons.

Sara Fisher – Friends of Inwood Hill Park: Forest School, children 1 – 5, 11/9, 9:30 – 11:30 NYRP

Audrey Jimenez - Community Outreach Coordinator of the Breast Cancer Society of Manhattan. Breast Cancer awareness month pre-screening event on Saturday 9-4pm, mobile mammogram. Blood pressure screenings also available. Flyers distributed

**Wayne Benjamin** – Speaking as the President of the Grinnell Co-op Board. The importance of staying on-top of the efforts to amend local law 64 of 2018. Was supposed to address the developers receiving benefits who are not registering the units in the system. The Grinnell has been caught-up in this law, and needs amendment to rectify a wrong categorization against them

  - No Discussion
- B. Resolution reinstating eliminated Bx7 Bus Stops in Wash. Heights & Inwood via the Bronx Bus Redesign
  - No changes, even though an update was given tonight
  - Deborah Nabavian voiced her opposition to this resolution due to the language in the resolution with regard to the Bus Stop distance). Agreed by Chair Martinez and responded to.
  - Other members spoke-up on their support of the resolution (Jay Mazur& Jim Berlin).
- Parks & Cultural Affairs: Elizabeth Loris Ritter
- C. Resolution Opposing the proposed Msgr. Kett Playground Comfort Station Renovation
  - Gave background on the wish for the comfort station to have gender neutral bathrooms, against Parks Dept. procedure and inflexibility
  - Question: Did committee consider pushing this as a general resolution? Chair Ritter: No.
     We called upon the Parks Dept. to make that policy change but did not want to overstep the bounds or ask too much.
  - Question: Can we change the language of the resolution from gender neutral to all gender? Chair Ritter: Understood, but gender neutral is the optimal language because it has a definition in law

#### Discussion on the Licensing Committee Resolutions:

Chair Isidro Medina opened the discussion. Highlights follow:

- 6 of the 29 resolutions on the calendar have been withdrawn. (12, 14, 25, 26,29, 31)
- Agenda item 22 and 28 to be reversed from Yes to No because they have not submitted the proper requirement
- Barbara Frasier questioned Item 18's true owner identity. Isidro Medina replied that the
  committee's job is not to make a determination of ownership but has moved the item along
  because a lease was produced.

- Liz Ritter mentioned a resolution passed in 2018 in regard to *Item 18's* issues of lease ownership. *Moved for this item to be withdrawn from consideration and tabled until we get a legal determination*. Moved and seconded. Conversation on if a motion-to-table can even be discussed. Determined that they are not debatable.
