Dear Speaker Mark-Viverito:

At the General Meeting on Tuesday, October 27, 2015 Community Board 12 Manhattan, passed the following resolution with a vote of (32)In favor; (0)Opposed; (1)Abstain; recommending to the City Council that at West 214th Street and Broadway, on the west side, in front of Carrot Top Pastries, be co-named Renee Mancino Way.

Whereas: Renee Mancino was a powerhouse of a personality who made a lasting impression with her baking skills and largesse who came from Cleveland, Ohio to the Big Apple in the early 1970's to pursue a career in mortuary science; and

Whereas: Renee settled in New York City, became engaged, found a job in her chosen career, had a child, but unfortunately her first career was derailed by a car accident; and

Whereas: Knowing she had to have an income, Renee fell back on her Midwestern traditions and training to her Grandma's old-fashioned recipes and bake sales, and that is the story of Carrot Top Pastries inception; and

Whereas: From a small one-bedroom apartment in Inwood, Renee began baking from a residential kitchen and her first client lists included inmates from all the local prisons, including Sing-Sing, Rikers Island and several more, and her view on this special act of kindness was that even the incarcerated deserved the indulgences of homemade pastries; and

Whereas: Life went on and as luck would have it another bump in the road occurred; during a visit from Ohio, Renee's youngest brother, while being trained to help his sister's growing business, experienced a serious incident with a sharp-edged knife; New York's Finest were called and Police Officer Robert Mancino stepped into Renee's life; and

Whereas: A brick and mortar building was found at 5025 Broadway on West 214th Street; while renovations took place under Robert's direction, Carrot Top Pastries had a real home now and he took early retirement from the NYPD and became an active partner with the new Mrs. Renee Mancino; and

Whereas: Renee was known equally for her delicious baked goods and remarkable dedication to the community as she generously donated for over 35 years to houses of worship, senior centers, little leagues, neighborhood groups, cultural institutions, historic houses, colleges, universities, police, fire and sanitation departments in the Washington Heights-Inwood community; and

Whereas: Renee baked for Morgan Freeman, Stevie Wonder, Archbishop Desmond Tutu, Harrison Ford, Roberta Flack, Richard Pryor and hundreds of other celebrities and thousands of Washington Heights-Inwood community residents since 1979; and

'Vhereas: The community was graced by Renee's quirky sense of humor and remarkable way of putting one at ease; all his was gently folded into her tasty and so delightful delicacies; she will forever be loved, admired and missed; now, therefore be it
