At the General Meeting on Tuesday, March 28th, 2017, with a vote of [33] in favor, [0] opposed, [0] abstain, [0] not voting, Community Board 12, Manhattan, passed a resolution of **Objection** to the New York State Liquor Authority Restaurant Wine License renewal application for La Nueva Juquila Restaurant Inc.; and

Whereas, La Nueva Juquila Restaurant Inc. – 2106 Amsterdam Avenue, (bet. West 164th & W. 165th Streets.) New York, NY 10032, has duly notified Community Board 12 Manhattan of its intention to file an application for a renewal of its Restaurant Wine License; and

Whereas, the Licensing Committee met on March 8th, 2017 to hear comments from the community and the precinct regarding the establishment's renewal application; and

Whereas, the establishment is on a street level of a of a five (5) story building with 12 residential units (R7-2 with C1-4 Commercial Overlay and no on-site parking facility); and

Whereas, the restaurant operates with total of 11 tables and 50 chairs. Hours of operation 5PM to 4AM seven (7) days a week; and

Whereas, the restaurant's legal capacity is 66 persons and the establishment's Method of Operation as stipulated with the New York State Liquor Authority includes Juke Box and recorded music only; and

Whereas, the CB12M licensing renewal application shows Live Music as part of the establishment's Method of Operation; and

Whereas, the current New York State Liquor Authority license does not permit Live Music; and

Whereas, the renewal request is not consistent with the existing New York State Liquor Authority license; and

Whereas, the 33rd Precinct has conducted numerous underage operations in the establishment that resulted in violations. The latest one was on February 25th, 2017. Additionally, during a separate special operation on March 3rd, 2017, the owner of the establishment received two (2) New York State Liquor Authority and three (3) NYC DOH violations; and

Whereas, per the 33rd Precinct there is a pattern of violations with this establishment: in a July 25th, 2013 operation, the bartender sold alcohol to a minor. The bartender was arrested and later fired. This incident happened under the current owner; and

Whereas, a double stabbing occurred in 2016 outside the establishment over a fight that started inside the restaurant; and

Whereas, the last NYC Department of Health inspection resulted in 80 violations and a previous inspection resulted in 40 violations of very unsanitary conditions, hand washing, and wrong dishwashing soap. Additionally, there is a newly opened rehabilitation center very close to the establishment; and

Whereas, applicant stated that she is not aware of any issues in her establishment; and

Whereas, the 33rd Precinct does NOT recommend a renewal for this Restaurant Wine License application; and

Whereas, the New York State Liquor Authority showed multiple additional violations, including:

- 11/02/13 failure to display license
- 10/22/16 failure to conform to application
- 10/22/16 prohibited hours of alcohol consumption
- 10/29/16 alcohol sale to minor
- 12/18/16 alcohol sale to minor; therefore be it

Resolved, that Community Board 12, Manhattan **Objects** to the New York State Liquor Authority renewal of Restaurant Wine License for La Nueva Juquila Restaurant Inc.
