The following resolution was passed by Community Board 12, Manhattan at its last General Meeting on April 23, 2002.

- Whereas:** A public hearing was held on March 6, 2002 at the office of Community Board 12, Manhattan, to discuss the aforementioned consent for a permit to operate an unenclosed sidewalk café with 19 tables and 38 seats at 3939 Broadway; and
- Whereas:** Mr. Kevin Rasquinha representing the restaurant appeared before the Economic Development committee to answer questions regarding the operation of the unenclosed sidewalk café; and
- Whereas:** Mr. Kevin Rasquinha has volunteered to participate in the "Adopt-a-Basket" program, and committed to keeping the outdoor café area clean; and

- Be it Resolved:** That Community Board 12, Manhattan, recommends the approval of a one year license issued to Wen-Kev, Inc. d/b/a Wendy's to operate an unenclosed sidewalk café at 3939 Broadway on the south side of West 165th Street and Broadway.
