Re: Rescinding Support for the Portion of the New York Main Street Grant Earmarked for The Hispanic Society of America

Dear Commissioner Calogero:

Community Board 12 passed this April 25th resolution with 36 in favor, 0 opposed, 2 abstained to rescind our support for the portion of the New York Main Street Grant earmarked for The Hispanic Society of America.

Whereas: On April 26, 2005, Community Board 12-Manhattan unanimously approved a resolution in support of an application to the New York State Division of Housing and Community Renewal (DHCR) for a New York Main Street Alliance grant that, among other things, would provide \$100,000 for repairs to the Hispanic Society of America's (HSA) buildings on Audubon Terrace; and

Whereas: In a letter requesting the board's support dated April 25, 2005, Mitchell A. Codding, HSA's executive director, stated, "The purpose of this grant is to support the Hispanic Society as a cultural anchor for the 155th-157th Street area along Broadway"; and

Whereas: During the presentation at the board meeting, the board was assured that HSA was no longer considering moving away, and the board reinforced that point by urging HSA "to make a commitment to remain in the Washington Heights community"; and

Whereas: Although Community Board 12 consistently has shown its interest in working with HSA and other interested parties "to preserve and strengthen" the society's place in our community, Mr. Codding has spurned our offers of assistance; and

Whereas: Without any prior notice or discussion with the community, HSA's board of trustees unanimously voted in February to pursue plans to sell its three buildings on Audubon Terrace – about half of the landmark complex – and move to a location in downtown Manhattan yet to be selected; and

Whereas: It is now clear that Community Board 12's support for the \$100,000 grant for the HSA was solicited on false pretenses; and

Whereas: It would be outrageous to use public funds to improve HSA's buildings and thereby enhance their resale value to facilitate its plan to abandon the Washington Heights community, especially in light of the fact that HSA has a \$65 million endowment; and

Whereas: The departure of the Hispanic Society would be a devastating blow to our community's cultural assets and would severely undermine the viability of the Audubon Terrace complex, the gateway to Washington Heights; now, therefore

Be It Resolved: Community Board 12-Manhattan rescinds its support for that portion of the New York Main Street Alliance grant earmarked for the Hispanic Society of America and calls upon the New York State Division of Housing and Community Renewal to re-designate these funds for the benefit of another institution that is committed to staying on Audubon Terrace and be an active Washington Heights-Inwood cultural participant.
