The following resolution was passed by Community Board 12, Manhattan at its general meeting on January 22, 2002:

Whereas:

A proposal to establish a community residence for mentally disabled persons at 790 Riverside Drive by the Program Development Services, Inc., a community service agency based in Brooklyn, was the subject of a Public Hearing of the Health and Environment Committee of Community Board 12 Manhattan, and

Whereas:

The facility would be located within ZIP code 10032, where at least eight (8) such state-funded facilities currently exist, in addition to major programs at the New York State Psychiatric Institute, a voluntary medical center and its associated medical and public health schools, and other residential programs funded by agencies other than the New York State Office of Mental Retardation & Developmental Disabilities, and

Whereas:

The co-op owners of 790 Riverside Drive and residents of the immediate area expressed concerns over the high number of such facilities in the area, safety issues and cited other adverse conditions affecting the suitability of the site proposed, and

Whereas:

There are more of these facilities in this ZIP code than in any other ZIP code in Community Board 12, and

Whereas:

There is an over-concentration of such facilities in the vicinity of the proposed site, therefore

Be It Resolved: Community Board 12 does not approve of the proposal by the Program Development Services, Inc. at this

location, and

Community Board 12 urges the New York State Office of Mental Retardation and Developmental Disabilities to improve its procedures under the State's Padavan Law, including the agency's notification and public hearing requirements, and to provide more accurate information on the total number of federal, state, city and privately sponsored mental health and related facilities, residential and outpatient, located in the community district.
