Whereas the Economic Development Committee of Community Board 12 met in public hearing on March 24, 2008 with members of the public, public officials, representatives from Precinct 34, owners of Mamajuana Café, to consider the issues and concerns of the public regarding the renewal and expansion of a Sidewalk Café in front of Mamajuana Restaurant at 247-9 Dyckman Street; and

Whereas those quality of life and public safety issues raised at the hearing by local residents have been adequately expressed, and acknowledged by the owners of Mamajuana Café; and

Whereas the owners of Mamajuana Café agree to be more responsive to public concerns, appointing a representative to act as a community liaison and posting that information plainly within the restaurant; and

Whereas the owners are making a good faith effort in increasing security around the restaurant to address quality-of-life issues such as double and triple parking, cars standing or parked near the restaurant with music at an unacceptable level by hiring more security staff; and

Whereas Mamajuana's owners have agreed to address and resolve issues of noise and vibration coming into the residential building above the restaurant; and

Whereas Mamajuana's owners have agreed to lower the volume of music within the restaurant when reasonable complaints are made by their neighbors; and

Whereas CB12 has agreed to address issues of public safety, parking and street noise around Mamajuana with the appropriate agencies; and

Whereas the owners of Mamajuana have agreed to limit the extension of the café to include no seating on Seaman Avenue past the front line of the building, as shown in the architect's revised plans presented to the Community Board March 25, 2008; and now

Therefore Be It Resolved, that Community Board 12 recommends the Department of Consumer Affairs grant a Renewal and Extension of the Sidewalk Café, as revised per agreement between owners of Mamajuana (Vida Café, Inc.), their neighbors, and the Community Board 12M at the Public Hearing dated March 24, 2008.
