Whereas:

Article 5.01 of the By-laws of Community Board 12, Manhattan state that "sufficient cause for removal of appointed board members shall consist of any one of the following:"

"(1) Three unexcused absences during any six consecutive months from duly called regular general meetings of the board."

"(2) Three unexcused absences from any duly called meetings of any standing committee(s) if that is the member's only standing committee appointment during any six consecutive months"; and

Whereas:

Board member Juan Sanchez has not attended a single meeting of any kind – New Member Orientation, Public Hearing, General Meeting or Committee Meeting – since having been appointed in May '03; and

Whereas:

Mr. Sanchez did not respond to a certified letter dated 9/16/03 which stated, "your lack of written response to this letter within 30 days will signify your resignation"; therefore

Be it Resolved:

That Community Board 12, Manhattan recommends that the Borough President remove Juan Sanchez from the Board for cause.

Dear Commissioner Dykstra,

The following resolution was passed by a majority vote of Community Board 12, Manhattan at its General Meeting on Tuesday, November 25, 2003:

Whereas, a Public Hearing was held at the Isabella Geriatric Center, located at 515 Audubon Avenue, on November 6, 2003 to discuss an application submitted by Javier & David Restaurant Corp., d/b/a Caridad Restaurant, located at 1618 St. Nicholas Avenue (southeast corner of West 191st Street), for a recommendation to operate an enclosed sidewalk café with a total of 9 tables and 29 seats; and

Whereas, Eduardo Lopez, Attorney at Law, and J. Alberto Robaina, AIA, architect, presented the plans and along with restaurant's owner, Miguel A. Montas, answered questions regarding the enclosed sidewalk café; and

Whereas, the plans show 7 tables and 23 seats to be placed on the southeast side of St. Nicholas Avenue near West 191st Street, and 2 tables with 6 seats to be placed on the south side of West 191st Street between St. Nicholas and Audubon Avenues; and

Whereas, the proposal is to build 10 feet from the restaurant onto St. Nicholas Avenue and leave 10 feet for pedestrian use, and on West 191st Street to build 6 feet from the restaurant and leave 8 feet, 8 inches for pedestrians; and

Whereas, the enclosed sidewalk café will increase the restaurant's occupancy from 40 to 69 persons and provide 7 - 8 new jobs for community residents, and

Whereas, the restaurant will be soundproofed and all construction will comply with the provisions of the Americans with Disabilities Act; and

Whereas, Mr. Montas assured the restaurant's garbage and recycling will be covered and stored in basement-level receptacles; and that bicycles will be stored in a way that does not impede pedestrian flow; and

Whereas, Mr. Montas volunteered to participate in the "Adopt-a-Basket" Program and committed to keeping the restaurant's front area clean; therefore

Be it Resolved: Community Board 12, Manhattan, recommends the Department of Consumer Affairs approve a one-year license for Javier & David Restaurant Corp., d/b/a Caridad Restaurant, to operate an enclosed sidewalk café with 9 tables and 29 seats.

There is no gymnasium, auditorium, cafeteria nor space for science labs or library; and

Whereas:

Most classrooms have no windows, the stairways are extremely narrow, allowing only single-person

passage, and there is an inadequate and often non-functioning ventilation, cooling and heating

system; and

Whereas:

The proposal to add two floors to the existing school is unacceptable and will not resolve most of the

school's existing problems; therefore

Be It

Resolved:

That Community Board 12, Manhattan demands a new site for the Gregorio Luperon High School in

or bordering Washington Heights & Inwood and that it be of the highest priority in the five-year Educational Facilities Plan now being considered by the Department of Education and the

community school boards.
