the establishment will employ approximately 200 individuals mostly from the Washington heights & Inwood area; and

WHEREAS,

Jose Felix Cabrera also stated that there will be approximately 65 video cameras (10 outside and 55 inside) throughout the establishment; There will be no live music, no traditional DJ and no dancing; Soundproofing will be installed throughout the entire establishment; the establishment will use the same security company as La Casa de Mofongo; and

WHEREAS,

the establishment will serve breakfast, lunch and dinner; the hours of operation are Monday – Thursday 6 am – 1am and Friday – Sunday 6 am – 4am; and therefore be it

RESOLVED, Community Board 12 (Manhattan) recommends the State Liquor Authority grant a new *On-Premises*Liquor License for South Beach Restaurant & Bar LLC dba South Beach Restaurant & Lounge, located at 1390 St. Nicholas Avenue providing that they observe all accessibility requirements and work to prevent quality of life issues in their local community; and be it further
