Manhattan Community Board 12 unanimously passed the following resolution September 27, 2005 recommending extension of the special permit granted 21 Hillside Avenue LLC for operation of a 48-car public parking lot at 21-23 Hillside Avenue.

Whereas, on June 23, 2005 an application (the "Application") was submitted to the NYC Board of Standards and Appeals ("BSA") by Harry Meltzer, RA (the "Applicant") on behalf of 21 Hillside Avenue LLC (the "Owner") for an extension to the term of a special permit for the parking lot located at 21-23 Hillside Avenue, Block 2170/Lot 110 (the "Property"); and

Whereas, the Property is a public parking lot that has 50 feet of frontage on Hillside Avenue and a depth of approximately 201 feet, accommodates approximately 48 cars and does not belong to any adjacent residential building, i.e.: it is a stand-alone parking lot as defined by zoning; and

Whereas, public parking lots do not conform with the zoning / district use regulations for the area and require a special permit; and

Whereas, the Property was originally established as a use exception granted by BSA in October 1959 under Calendar # 357-59-BZ and this use exception was extended several times over the years with the last extension being in June 1995 (expired June 27, 2005) under BSA Calendar # 4-95-BZ; and

Whereas, at a Public Information Meeting held by the Land Use Committee at the Nagle Avenue YM/YWHA on September 7, 2005 to obtain public comment on the request for an extension to the term of the special permit neighborhood residents provided only positive remarks pertaining to the Property generally indicating that it provides a necessary, useful and affordable service;

Now, Therefore Be It Resolved, that Community Board 12-Manhattan supports the requested extension to the term of the special permit for the Property under the Application.

Whereas: Community Board 12's (CB12) Economic Development Committee met September 6, 2005 with the owners of eight businesses and members of the public to review the businesses new State Liquor Authority (SLA) license applications and to make a recommendation to the SLA on each application in accordance with the Alcoholic Beverage Control Law (ABC Law); and

Whereas: Each business owner(s) satisfactorily responded to questions and comments from the committee and members of the public regarding their business plan and operation, menu, hours, floor plan, occupancy, parking, sound-proofing, music, noise, sanitation, employment opportunities and other concerns; therefore

Be it Resolved: That CB12 recommends the SLA grant the following new licenses with the stipulation these businesses operate in accordance with all provisions of the ABC Law:

- 6) On-Premises Liquor for Washington Heights Billiard at 500 West 207th Street
