Whereas, the 33rd Precinct reported that for the last 12 months the establishment received over 263 noise complaints from over 3 tenants. Also stated that a brawl took place on November 6th around 3:25 am where someone was found unconscious on the floor. Further stated that the business received 3 different summonses, including one for warehousing alcohol without a permit. The establishment has also been summoned for selling alcohol without a license. Previously, this committee has rejected different requests from this establishment due in part to the many violations reported by the 33rd Precinct; and

Whereas, the new officer coming into the corporation works, was born, and continues to reside in the community. She will own 50% of the shares along with the Manager owning 50%. She owns an exterminating company for over 30 years in the community. She states that the manager will work with the Precinct to rectify the above-mentioned issues. They were closed for some time during the pandemic. The Manager stated that none of the summonses were registered with the SLA. As far as someone being unconscious is concerned, the operator stated that it was an isolated incident that had nothing to do with the bar. The operator claims that all these complaints come from one resident and that they have installed soundproofing to rectify the noise problem. The manager has been working there for over 40 years.

Whereas, the committee heard both sides of the story and requested a stipulation to display a phone number when and if there is a problem for the residents and or patrons to call the manager to rectify the problem; and

Whereas, Committee members complimented the venue for its service, history, and food. The Committee requested one stipulation to display a phone number of a manager in charge to rectify any pertinent issue with patrons or residents; therefore be it
