6. Migrant Crisis

- i. Tension in the city is at different levels. Shelters are overwhelmed by asylum seekers.
- ii. At the same time, NYC has the highest number of homelessness in the midst of a housing crisis. There is an intersection of several issues in housing and the migrant crises worsens it.
- iii. Data is needed on how many folks are present in our region or borough and how we are impacted.
- iv. Liz Ritter conducts event called Uptown Wagon with Mark Levine. 21st and 22nd of September. There will be donation collections and resources.
- v. Our communities are being put against each other because of the scarcity of resources. There are people that have been here for a long time that are already lacking resources. Being a sanctuary city puts more strife on an a stressed out city already. Hold elected officials accountable because we to have what we have. We have enough empty units in this region to house everyone.
- vi. Migrant Crisis Will break NYC- We have limits in resources and space. Something that has to be mentioned or taken into account.
- vii. How is it impacting the budget for our region? Is it a federal or state budget that is dipped into for resources.
- viii. Driven by court order that set off affordable housing development over last 40 years.

7. New Business

- i. Request to have Affordable housing communications/announcement within community- spread word about units like 37 hillside. More outreach.
- ii. Accessibility of community board listserv. Must share information with organizations and disseminate information.
- iii. Airbnb crackdown especially for rent stabilized building units through more enforcement. Registration will be required in the process of having an Airbnb in the city. Can be placed under a landlord issue category.
