At the General Meeting on Tuesday, May 24, 2016 Community Board 12 Manhattan, passed a resolution with a vote of (34) In Favor, (0) Opposed, (0) Abstain recommending the NYS Liquor Authority **not to grant a New On-Premise Liquor License to Park Terrace Café Corp., dba Cuevas Café.**

Whereas, Park Terrace Café Corp., doing business as Cuevas Café, located at 5025-5035 Broadway, (bet. W. 214th & W. 215th Streets.), has duly notified Community Board 12 Manhattan of its intention to file an application for an On-Premises Liquor License; and

Whereas, at the Licensing Committee held on May 11, 2016, significant concerns about this application were raised by members of the Committee, the 34th Precinct, and nearby residents due to the checkered history of this business operated under various owners over the last several years, and to the attendant deleterious effect on quality of life in the surrounding area; and

Whereas, the 34th Precinct, which is opposed to this application, noted that this location is once again in operation and apparently serving alcohol, despite not having a license; that since March of this year, the Precinct has received numerous complaints about noise coming specifically from this location; that when the business was recently operated as Cavala Café, there was an extensive history of excessive noise complaints, sales of alcohol to minors, unlicensed sale of alcohol, failure to display a license, failure to provide an obstructed view into the establishment, and hiring untrained and unlicensed security guards; and that arrests have been made and summonses issued for these offenses on at least six separate occasions; and

Whereas, the Precinct informed the Committee that there were 189 noise complaints regarding this location in 2015, and 18 complaints this year thus far; and

Whereas, when the applicant was asked why he was operating a business without the license to do so, he stated that he was unaware the business was open, later admitting that a soft opening had been held for friends and family, and then claiming that the business otherwise had not been in operation, although the Precinct and members of the Committee had witnessed the operation of the business at least several nights a week; and

Whereas, although the applicant claimed not to have any business relation with the previous ownership of Cavala Café other than as the purchaser of the business, members of the community informed the Committee that one of the owners of Cavala has been promoting the new business; and
