At the General Meeting on Tuesday, September 26th, 2017, with a vote of 32 in favor, 6 opposed, 1 abstentions, 0 not voting, Community Board 12 Manhattan, passed a resolution of **No Objection** to the New York State Liquor Authority On-Premises Liquor License renewal application for 524 Villa Riva Corp. dba Bakare Restaurant & Lounge; and

Whereas, 524 Villa Riva Corp. dba Bakare Restaurant & Lounge – 524 W. 207 St. (btw Post and Sherman Avenues) 10034, has duly notified Community Board 12 Manhattan of its intention to file an application for a renewal of its On-Premises Liquor License; and

**Whereas**, the Licensing Committee met on September 13, 2017 to hear comments from the community and the precinct regarding this establishment's renewal application; and

Whereas, the establishment is on the street level of a six (6) story building with 80 residential units; and

Whereas, the restaurant operates with a total of 23 tables 56 chairs and 10 bar stools, with a total maximum legal capacity of 74 persons. Hours of operation 5PM to 3:45AM, seven (7) days a week; and

Whereas, the Method of Operation includes Juke Box, and Recorded Music, only; and

Whereas, Eighty (80) families from 130-134 Post Ave submitted a complaint letter to CB12 stating that the establishment is running very loud music from 11PM to 4AM seven (7) days a week; and

Whereas, Community Board 12 Manhattan resolution dated 1/27/16 objected to this license; and

Whereas, the 34th Precinct reported the following issues with the establishment

- 2/23/17 stabbing inside the establishment, possibly by employee. The 34th was told the DVR did not work therefore could not retrieve images from the cameras
- 2/27/17 summons or unlicensed cabaret
- 4/23/17 summons for obstructing the view inside the establishment with shades, overcrowding, and disorderly premises
- 5/27/17 summons for overcrowding
- 6/21/17 summons for disorderly premises; and

Whereas, the 6/30/17 inspection by the 34th Precinct found no violations at the premises; and

Whereas, the applicant stated that the stabbing incident happened outside the establishment but the security cameras did not work. Applicant also stated that the Criminal Court dismissed the violations but did not have a copy of the judgment with her at the September 13th meeting; and

**Whereas**, the applicant also stated that the previous manager was not on top of the issues listed by the 34<sup>th</sup> Precinct; and

**Whereas**, the applicant has a scheduled meeting with the State Liquor Authority on October 22<sup>nd</sup> 2017 to address the summons indicated above. Applicant also received extension to pay the fine until Sunday, September 24<sup>th</sup> 2017; and

Whereas, the applicant agreed in writing to implement the stipulations stated below prior to the Community Board General Meeting on September 24th, 2017

- Install Good Neighbor Sign
- Remove blinds
- Provide proof of violation dismissal
- Post phone number of manager for residents
- Keep security equipment in good working order at all times
- Meet with the 34th Precinct; therefore be it
