Re: Letter Supporting New York Restoration Project's Grant Application for Woodlands Restoration in Highbridge Park

Dear Mr. Reynoso:

At the Executive Committee meeting on Thursday, January 12, 2017 Community Board 12, Manhattan passed the following resolution with a vote of 10 in favor, 0 opposed, 0, abstention, supporting the New York Restoration Project's proposal for woodland restoration in Highridge Park along the Harlem River. This Executive Committee action was ratified at the January 24, 2017 Community Board 12, Manhattan General Meeting with a vote of 36 in favor, 0 opposed, 0 abstaintion, and 1 not voting due to conflict.

Whereas: the New York Restoration Project ("NYRP") has been a dedicated champion of open space in northern

Manhattan for more than 20 years, helping to reclaim and maintain parkland in Highbridge, Fort Washington and Fort Tryon Parks, and in Sherman Creek, in collaboration with New York City's Department of Parks & Recreation ("NYC Parks") to enhance places of incredible beauty for better community and recreational use;

and

Whereas: NYRP is applying to the New York State Department of Environmental Conservation for a grant to aid in a

three-year reforestation plan in Highbridge Park to plant more than 1,500 trees of native species and to

remove invasive species that choke native trees, decrease visibility and mar the general landscape; and

Whereas: this plan has been developed in conjunction with NYC Parks' Forestry and Natural Resources Division, and

NYRP will be working under the oversight of NYC Parks, the steward of these public lands, which is deeply

invested in the care and maintenance of New York City's open spaces; and

Whereas: Community Board 12, Manhattan ("CB12M") is grateful for the work the NYRP has done and plans to do as it

has improved and will continue to improve the beauty, enjoyment and public safety of our parks, including helping to restore some of New York City's most vibrant natural forests to their former glory and returning open and green waterfront access to the Washington Heights & Inwood communities of Community District

12, Manhattan; and

Whereas: CB12M has helped NYRP to publicize many events in our parks over the last two decades and previously

has supported NYRP's work in our parks through resolutions passed in September 2011 and April 2015;

now, therefore, be it
