- 1 The estimated attendance at this event is: 1000 to 4999.
- 2 The event will include live entertainment and/or celebrity appearances. Following are the live entertainment and/or celebrity appearance components: *There will be several live bands playing ambient music. This will include a traditional German brass band in keeping with the Oktoberfest theme of the event, and may include other bands playing lightly amplified background music as guests dine and enjoy games and events. Any stage or supporting setup for the band will be pre-fabricated*
- 3 The event will contain the following commercial branding and/or advertising elements: *Producer is a brewery that will supply the beer and food for the event. Obviously beer and food are a large portion of the appeal for an Oktoberfest-themed event and the relationship with Producer will be advertised prominently. This is the only commercial branding that will occur. The event is to benefit City Harvest and there will be advertising centered around City Harvests cause and mission.*
- 4 The event will be advertised. Following is the event advertising plan: *Both Sponsor and Producer will market this event primarily to their member list. City Harvest is New York Citys largest food rescue organization helping to feed the more than 1.5 million New Yorkers and has an extremely wide support network. Torch Crown has a large local following having served 50000 customers in its first year in business. By partnering with a local brewery for the events beer food and hospitality offerings and tapping into its local consumer base we will together ensure the event has maximum charitable impact. We will also work closely with the Hudson Square BID to market the event to local businesses and their followings in the area..*

- 5 The event will have on-site security. Following is the on-site security plan: *We will utilize the services of All Purpose Protection a fully licensed and insured security company that specializes in large events. We expect 2000 guests throughout the course of the day and expect a maximum of 500 people at any given time though we will sell tickets in 2 time slots. We will have two security guards stationed at each entrance 4 entrances total with 5 more serving as floaters monitoring the inside of the event. At no point will we have more than 50 guests for every 1 security personnel member.*
- 6 There will be amplified sound. **An NYPD Sound Permit is required from the local precinct.**
- 7 Portable and/or tow-hook generators will be used at this event. **FDNY notification is required.**
- 8 There will be a stage, press platform or scaffolding at the event. Following are the dimensions and description: *TBD based on product availability, but stages will be low height and pre-fabricated.*
- 9 There will be a tent or a canopy at this event. Following are the dimensions and description: *There will be 400 sq ft tents to cover the dining areas only in case of rain. All tents will be securely installed and all sides will be open ie unenclosed.*
- 10 Food and/or beverages will be sold or distributed at the event. **A DOHMH Temporary Food Service Establishment Permit (via DCA) is required.**
- 11 There will be soliciting for services, products, charities, etc. (i.e. collecting signatures, selling tickets, collecting funds). **An HRA Permit to Solicit Funds is required**
- 12 Alcoholic beverages will be sold, consumed or distributed at this event. **This will require eligible restaurants/businesses /caterers to obtain a Temporary Beer and Wine Permit from the NYS Liquor Authority.**
