- 11 There will be a tent or a canopy at this event. Following are the dimensions and description: *Red carpet tent - no larger than 30 x 60*
- 12 There will be a tent or canopy that is more than 400 gross square feet and/or will be in place for 30 days or more. **A DOB Structure Permit is required**
- 13 There will be 75 or more people inside a tent that is closed on all 4 sides or 200 or more people in an enclosed area outside at the event. **A DOB Temporary Place of Assembly Permit is required. FDNY notification is required and a site inspection will be conducted.**
- 14 Food and/or beverages will be sold or distributed at the event. **A DOHMH Temporary Food Service Establishment Permit (via DCA) is required.**
