Agency Instructions

- 1 The estimated attendance at this event is: 500 to 999.
- 2 There are plans to include live entertainment and/or celebrity appearances. Following are the live entertainment and/or celebrity appearance components: *This is an afterparty for the Met Gala that is an extension of an event at the Soho House hotel and there will be celebrity attendees at the event. There is not intended to be any name talent performing, however celebrities will be present*

- 3 The event will contain the following commercial branding and/or advertising elements: *An automotive brand is sponsoring the event and will have vehicles and elements in the street.*
- 4 There will be red carpet, rope and/or stanchions used at this event.
- 5 There will be a step and repeat banner at the event.
- 6 The event will have on-site security. Following is the on-site security plan: *We will have security and maintain a secure perimeter with barricade and within the barricade there will be a minimum of a 1:50 ratio of guards to attendees. As part of our security plan we will likely want to hire NYPD officers and will consult with the local precinct to do so..*
- 7 There will be amplified sound. **An NYPD Sound Permit is required from the local precinct.**
- 8 Truck-mounted generators will be used at this event. **FDNY approval is required.**
- 9 Generators with a greater than 40 kW rating will be used at the event. **A DEP registration permit is required.**
- 10 There will be oversized construction equipment at this event. Following are the details:*We will have a telehandler as part of our event holding up a prop and forklifts used for setup.*
- 11 There will be a stage, press platform or scaffolding at the event. Following are the dimensions and description: *Yes we will have scaffolding for dancing models approximately 12ft tall with a 10ft x 10ft footprint.*
- 12 There will be a stage, press platform or scaffolding that exceeds two (2) feet in height and covers an area of 120 square feet or more, and/or will be in place for 30 days or more. **A DOB Structure Permit is required.**
- 13 There will be a prop at this event. Following are the dimensions and description: *We will have speaker towers at approximately 12ft tall.*
- 14 There will be a prop that is higher than 10 feet at this event. **A DOB Structure Permit is required.**
- 15 There will be a truss at this event. Following are the dimensions and description: *Yes we will have scaffolding for dancing models approximately 12ft tall with a 10ft x 10ft footprint. These elements will additional have lighting instruments.*
- 16 There will be a truss that is higher than 10 feet. **A DOB Structure permit is required.**
- 17 There will be 75 or more people inside a tent that is closed on all 4 sides or 200 or more people in an enclosed area outside at the event. **A DOB Temporary Place of Assembly Permit is required. FDNY notification is required and a site inspection will be conducted.**
- 18 Food and/or beverages will be sold or distributed at the event. **A DOHMH Temporary Food Service Establishment Permit (via DCA) is required.**
- 19 Alcoholic beverages will be sold, consumed or distributed at this event. **This will require eligible restaurants/businesses/caterers to obtain a Temporary Beer and Wine Permit from the NYS Liquor Authority.**
- 20 There are plans for after hours construction of a stage, press platform, or scaffolding. An After Hours Variance from the DOB is required.
- 21 There are plans for after hours construction of a prop. An After Hours Variance from the DOB is required.
- 22 There will be after hours construction of a truss. A DOB After Hours Work Variance is required.
