- 1 This event has been held previously. Following are details of the previous occurrence(s): *LREI Street Fair 6/4/23 692342 and LREI Centennial Street Fair 6/5/22 624315.*
- 2 The estimated attendance at this event is: 200 to 499.
- 3 There are plans to include live entertainment and/or celebrity appearances. Following are the live entertainment and/or celebrity appearance components: *We will have live performances from students i.e. Lower School Chorus Middle School Chorus Band 6th Grade Medieval Guilds HS music groups in our community as well as a kid-friendly DJ. There will not be any celebrity appearances.*
- 4 The event will contain the following commercial branding and/or advertising elements: *Yes we will have our schools branding at the event.*
- 5 The event will be advertised. Following is the event advertising plan: *Yes we will be promoting the event on our schools Instagram*

and in newsletters to our community..

- 6 The event will have on-site security. Following is the on-site security plan: *We will have our school security guards and school nurse onsite. Parent volunteers will also assist in securing the edges of the block festival to make sure children dont go into the road and that bikers and cars dont come in. We will also have parent volunteers at all rides and booths to ensure safety..*
- 7 There will be amplified sound. **An NYPD Sound Permit is required from the local precinct.**
- 8 Portable and/or tow-hook generators will be used at this event. **FDNY notification is required.**
- 9 There will be open flames (i.e. candles, sterno, etc). Following are the details: **An FDNY Open Flame Permit is required.**
- 10 There will be a stage, press platform or scaffolding at the event. Following are the dimensions and description: *Our school has 3 risers each riser is 4ft long x 5ft wide that can be combined to create one singular stage that covers an area of 60 square ft. The stage dimensions: 12ft long x 5ft wide x 1ft tall.*
- 11 There will be a tent or a canopy at this event. Following are the dimensions and description: *Like last years street fair we plan to rent approximately 24 open canopy tents 10ft x 10ft to help protect against weather elements i.e. rain provide shade.*
- 12 There will be general vendors at this event. **A DCA 30-day Street Fair Vendor Permit is required.**
- 13 Vendors are paying to participate in the event
- 14 Food and/or beverages will be sold or distributed at the event. **A DOHMH Temporary Food Service Establishment Permit (via DCA) is required.**
- 15 There will be carnival games at this event. **This requires a DCA 30-day Street Fair Vendor permit for each vendor.**
- 16 There will be "Game(s) of Chance" at this event. **This requires that each operator obtain a valid license to conduct a 'Game of Chance' from the Department of Consumer Affairs.**
- 17 There will be inflatable rides at this event. **A DOB Certificate of Compliance is required.** *2 bouncy houses and an inflatable obstacle course provided by Aardvark Amusements.*
- 18 There will be truck-mounted rides at this event. **A DOB Certificate of Compliance is required.** *1 Pirate Swing comes attached to a pickup truck provided by Aardvark Amusements.*
