Re: New Zoning Narrative Premises: 110 Christopher Street, New York, New York BSA Cal. # 16-93 BZ

Dear Commissioners:

In accordance with the Board's requirements for a narrative stating the applicable new UG's and ZR sections, please see below:

The application is for an extension of the term of variance which expired on February 24, 2024 and for an amendment so as to approve a change in commercial uses in the cellar. The former approved use for the now vacant spaces was that of a custom dressmaker within Use Group 6. That use is currently designated as Use Group X under the new City of Yes regulations. Both vacant spaces were then leased as an Art Gallery within Use Group 6c under the old zoning and now as Use Group VIII under the new zoning. The Art Gallery vacated the spaces on or about July 1, 2024.

The office use for a music store located in the most westerly part of the cellar was previously included in U.G. 6. Office spaces are now classified in Use Group VII. With respect to proposed uses for the vacant spaces, we are proposing to have either a use included in Use Group VI for Retail Stores and/or Services and for the office use to continue as Use Group VII.

There are no changes to current ZR sections to my knowledge. See annexed chart.
