- 10 There will be domesticated animals present as part of this event.
This requires an Animal Exhibit Permit from the Department of Health.
- 11 There will be inflatable rides at this event. **A DOB Certificate of Compliance is required.** *Possible inflatables provided by either Great Neck Games or New York Fun Factory.*
