- 8 There be special effects and/or fireworks (Including flame eaters, fire jugglers, etc). Following are the details: *Not the above specified items, but wanted to explain: A propane-fueled raku kiln will be operated by trained professional artists. Heated vessels are transferred to a covered metal reduction chamber, then cooled in a water bath. All equipment is managed in a designated, supervised safety zone. we will acquire FDNY approval..* **An FDNY Pyrotechnics Permit is required.**
- 9 There will be a tent or a canopy at this event. Following are the dimensions and description: *There will be open air shade structures Easy-up pop-up tents without side panels*
- 10 Food and/or beverages will be sold or distributed at the event. **A DOHMH Temporary Food Service Establishment Permit (via DCA) is required.**
- 11 There will be soliciting for services, products, charities, etc. (i.e. collecting signatures, selling tickets, collecting funds). **An HRA Permit to Solicit Funds is required**
