- 8 There will be open flames (i.e. candles, sterno, etc). Following are the details: **An FDNY Open Flame Permit is required.**
- 9 There will be a stage, press platform or scaffolding at the event. Following are the dimensions and description: *16 x 4*
- 10 There will be a prop at this event. Following are the dimensions and description: *speakers 3ft x 3ft. Telehandler // Reach Form Fork: used to hold disco ball.*
- 11 There will be 75 or more people inside a tent that is closed on all 4 sides or 200 or more people in an enclosed area outside at the event. **A DOB Temporary Place of Assembly Permit is required. FDNY notification is required and a site inspection will be conducted.**
- 12 Alcoholic beverages will be sold, consumed or distributed at this event. **This will require eligible restaurants/businesses/caterers to obtain a Temporary Beer and Wine Permit from the NYS Liquor Authority.**
