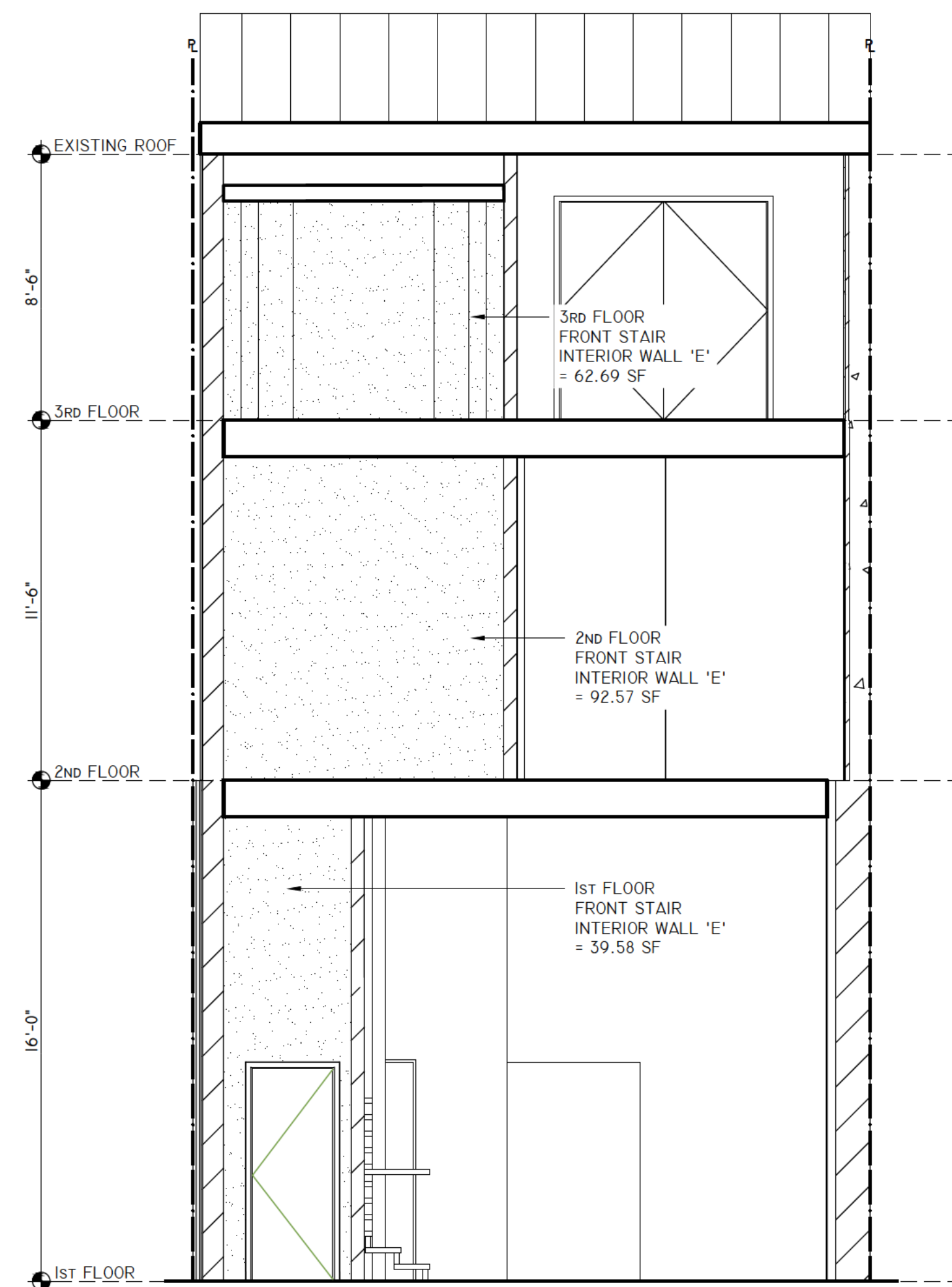


2ND FLOOR

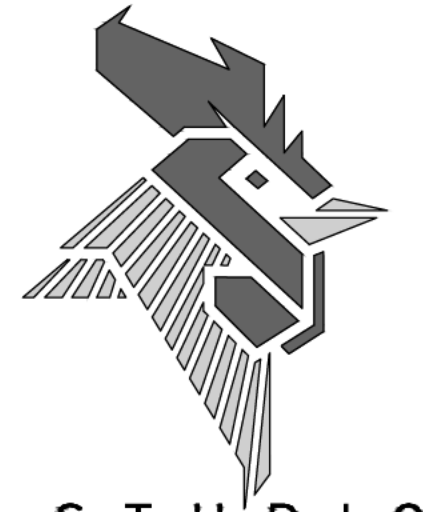


### FRONT STAIRCASE INTERIORS - INTERIOR WALL 'E'
