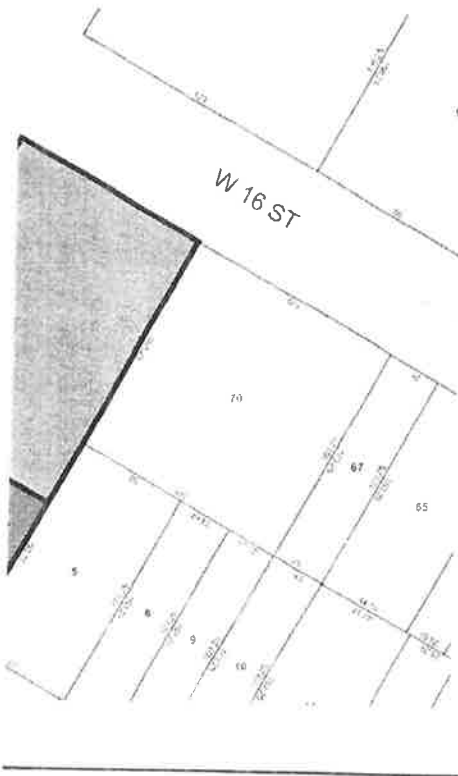

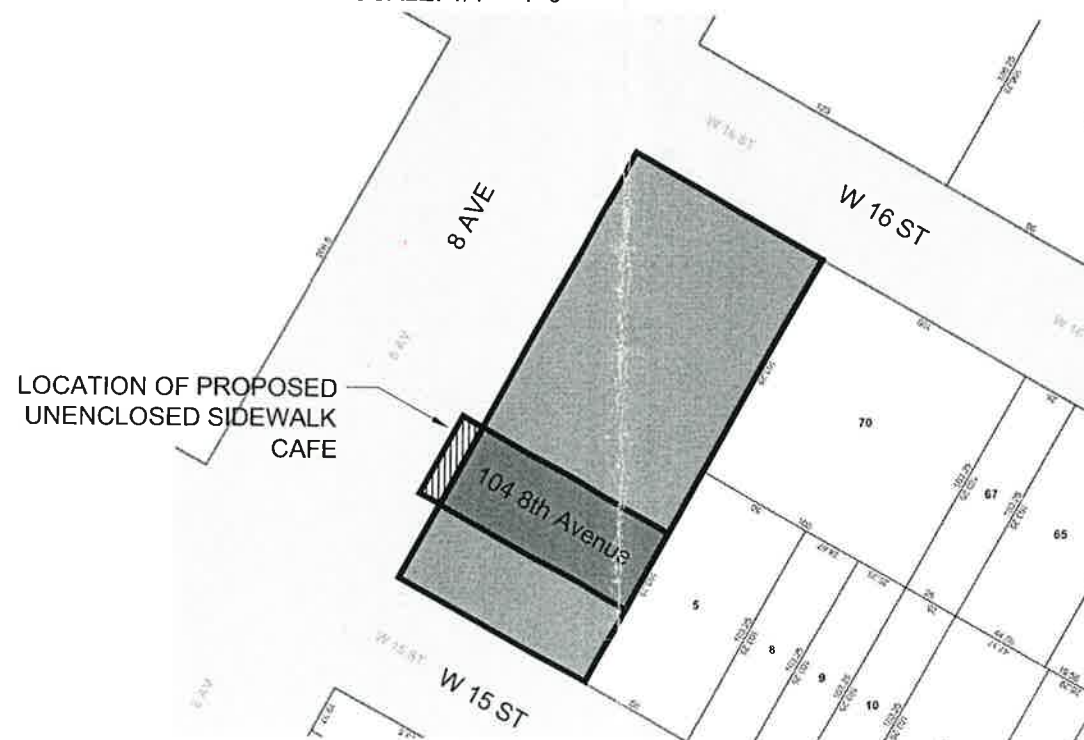
**01 ELEVATION - SIDEWALK CAFE**
