

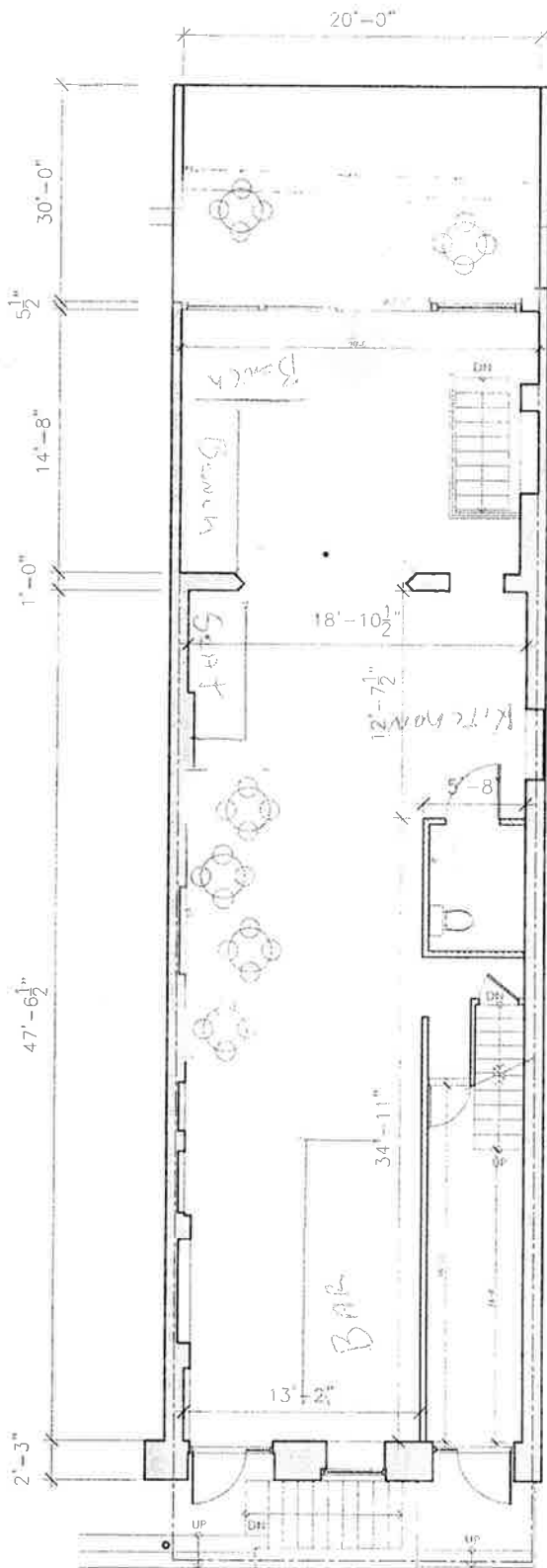

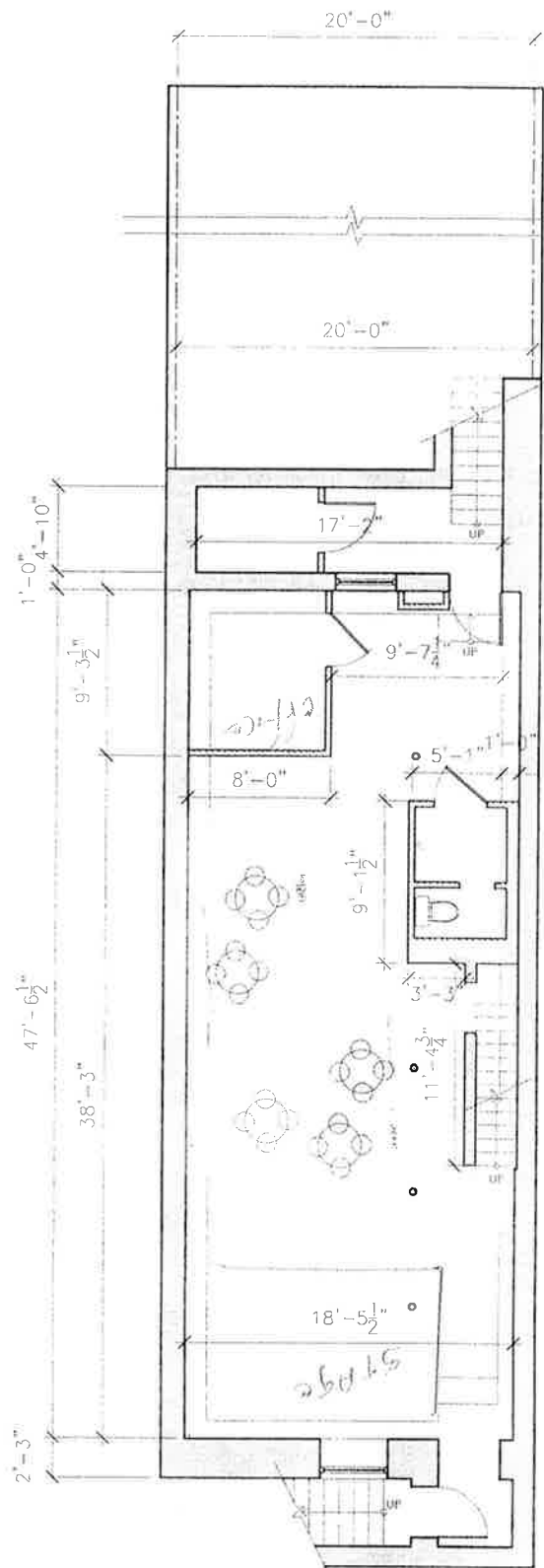

 A-101 SCALE : 3/32" = 1'-0"

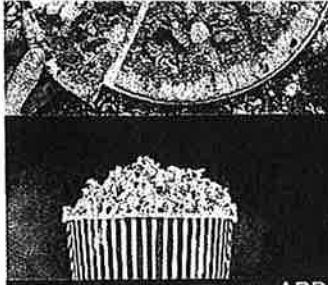
