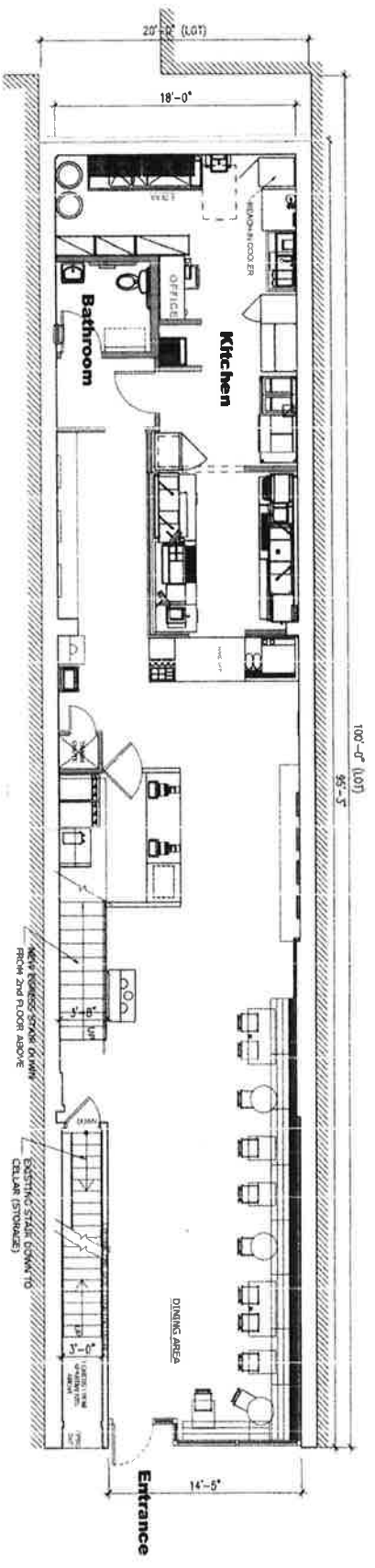

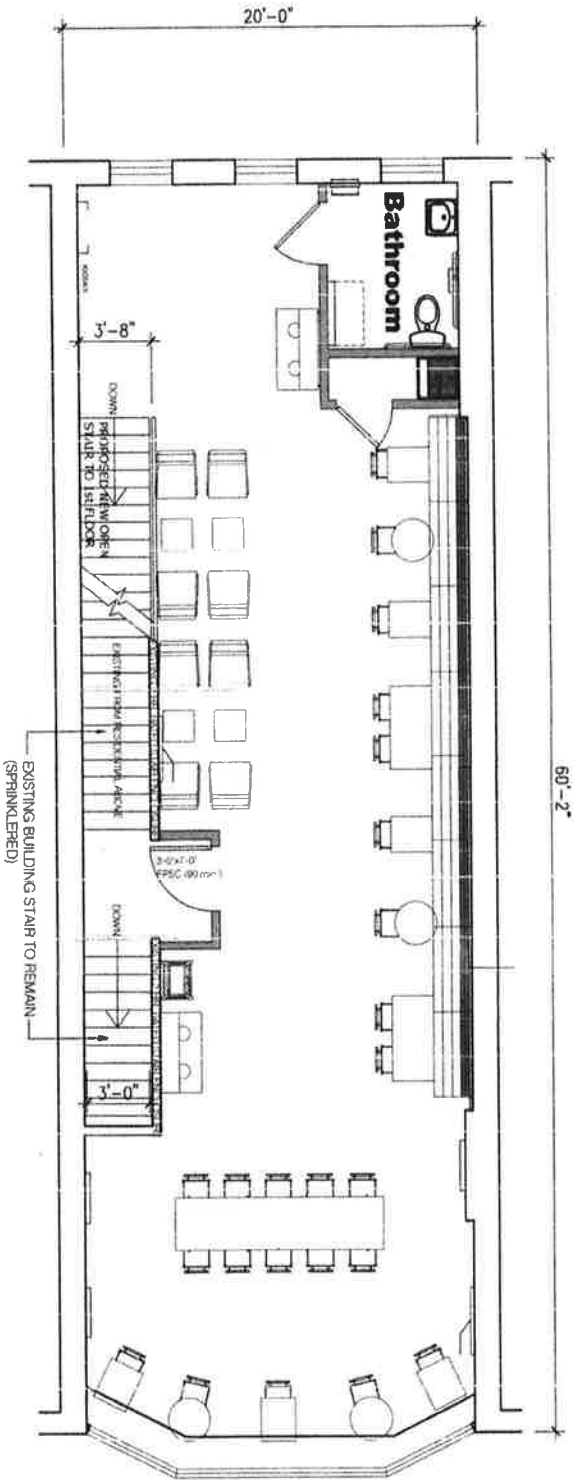
**BASEMENT DIAGRAM**


