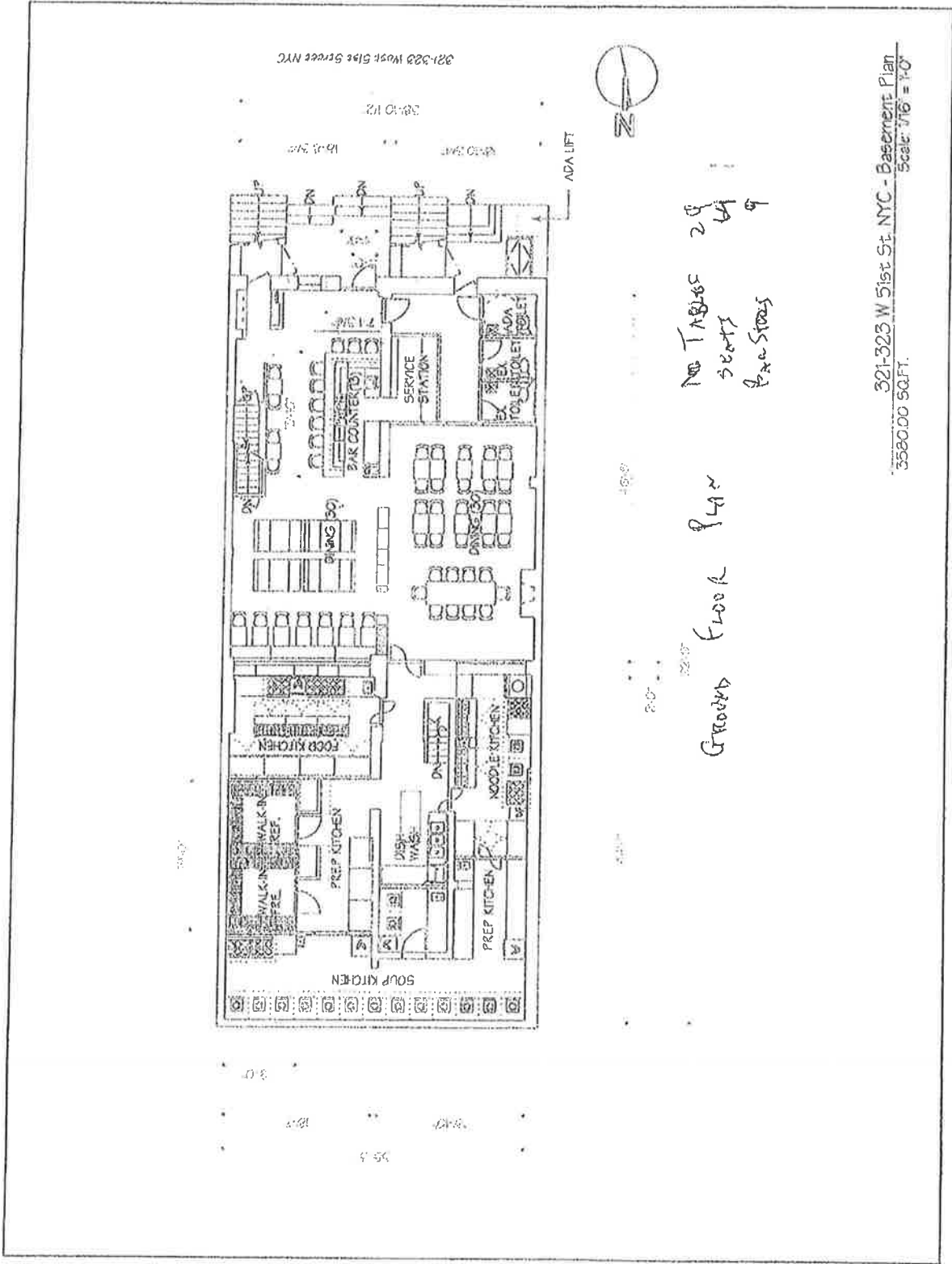


321-323 West 51st Street NYC
