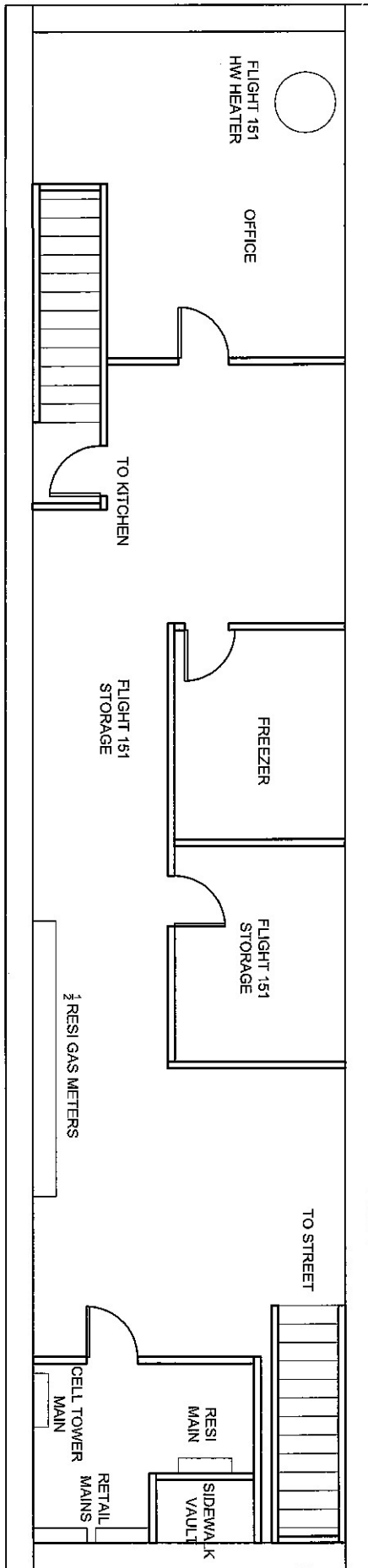




# FLIGHT 151 & CELLAR FLOOR PLANS

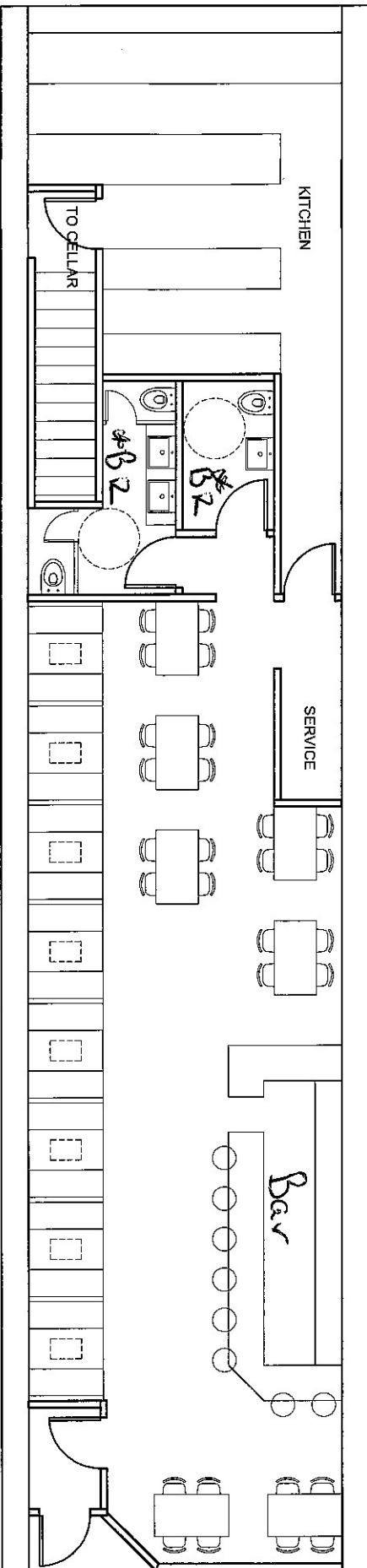
