- Urban Pathways – Port Authority Bus Terminal Update: **For September 297 duplicate encounters; 64 new encounters; 23 placed; 17 into drop in center, 4 received intake and seeing case managers, assisted 5 stranded individuals, 6 people were sent to detox, 1 person needed medical attention.**
