Breaking Ground CB 4 Report – April 2018

Catchment area:

- Breaking Ground's catchment area is 59th to 23rd Street, river to river. We conduct street outreach above ground, which includes the majority of the catchment area of Community Board 4.
- Breaking Ground conducts outreach in our catchment area 24/7.
- Downtown Goddard covers the rest of CB4 area that is south of BG, from 14th Street to 23rd Street.

311 Statistics:

- Community Calls: 51
 - o 19 during the day
 - 32 during evening, overnight or weekend
- Calls resulted in clients not found: 32
- Calls resulted in clients refusing services: 14
- Calls resulting in engagement with client: 5

Canvassing efforts:

- Breaking Ground outreach team conducts street outreach in your catchment area daily and visits encampments, hotspots, and chronic clients with the hopes of getting them linked with services.
- There are 10 hotspots in this location that the team focuses on visiting every week.
- In addition, clients on caseload receive weekly visits from their case managers to create a plan for housing.
- MOC conducted the Spring Quarterly Count on 4/29/18 4/30/18.

Joint Operations:

- The team continues to conduct weekly joint outreach with the Times Square Alliance every Wednesday morning.
- A cleanup with DHS, DSNY, NYPD and BG was conducted at 58th Street and WSH on 4/11/18.
- A cleanup with DHS, DSNY, NYPD and BG was conducted at 45th Street and 11th Avenue on 4/12/18.
- BG attended the Midtown South Community Council meeting on 4/3/2018 to discuss concerns regarding homelessness amongst other stakeholders and social service providers in the area.

Caseload Breakdown:

- On our caseload, we currently have 72 people who originate from CB4 area:
 - Stabilization beds 4
 - Safe Havens 25
 - Shelter -2
 - Permanently housed 15
 - Street 26
- Prospect/Pre-caseload clients 9

Placement Statistics:

In April 2018 – one client accepted and moved into transitional housing.

Significant information/Areas of concern in the past 30 days:

- 51st btw 11th and WSH This client continues to reside here with numerous belongings and canning materials. He continues to be engaged regularly by outreach and his case manager and is not receptive to services however willing to engage with the team when outreached.
- 42nd b/ 8th and 9th Ave --People tend to come and go frequently at this location, likely due to its close proximity to PABT. Throughout the day, the entrance to PABT on 42nd Street varies with its level of homeless activity. There has been a noticeable increase as the weather has gotten warmer towards the end of April. Some belongings are being stored on site near the entrance of 330 W. 42nd Street. The bus station/pizza shop on the corner of 42nd and 9th Avenue also became increasingly active with homeless activity during the month of April.
- **40th and 8th Ave** LinkNYC tower on SW corner remains an area of concern in regards to increased foot traffic of both homeless individuals and those in area for what team suspects to be related to drug activity.
- **39th between 8th and 9th Ave** The LinkNYC at this location has resulted in individuals continuing to congregate at this particular location. Team has observed drug related activity which attracts both homeless and non-homeless individuals to the area.
- 8th Avenue between 39th and 42nd Street- Homeless activity on 8th Avenue has increased during early morning, day and evening shifts; however, teams have not noticed an increase in individuals bedding down in the area at night. Teams suspect that this increase is related to drug availability in the area, team continues to engage with individuals who appear homeless. Many of which are observed to be under the influence or report that they utilize a methadone program in the area.
- **Chelsea Park** The area remains a location the team canvasses frequently as activity is known to increase as weather gets warmer. During the month of April, no more than 6 individuals were engaged at one time during outreach at this location. Many report to be sleeping closer to WSH or that they are not sleeping inside but spend their days at the park.
- 8th Ave b/ 33rd and 34th Street –This block is known to be active with panhandling and drug related activity. Team noticed an increase in activity at this location during month of April and has been canvassing the area daily to engage with individuals found here across all shifts however only 3 individuals are consistently sleeping in the area. Many individuals at this location can also be observed panhandling during the day on 7th Avenue.
- 8th Avenue between 35th and 36th Street- Area remains active during the day time shift, mainly with individuals loitering in the area and utilizing the nearby McDonalds as a location to spend time inside during the day. Many individuals continue to report to be in the area to attend their MMTP and can be observed hanging around after attending the program.
- **28th Street between 11th and WSH** Team continues to canvass this location regularly as it's known to fluctuate in regards to activity and many individuals engaged at Chelsea Park report to sleep at this location. Area continues to attract individuals as a bedded down location due to it being removed from heavy foot traffic.
- **36th and Dyer** Team continues to canvass the area as it continues to attract individuals as a bedded down location due to scaffolding and isolated triangle. Recently, 2 individuals new to the team have been engaged during evening and overnight shifts at this location.
