Re: Supporting Hell's Kitchen Neighborhood Coalition

Dear City and State Representatives:

On the recommendation of its Housing, Health and Human Services (HHHS) Committee, following a presentation by members of the Hell's Kitchen Neighborhood Coalition (HKNC), Manhattan Community Board 4 (MCB4) at its regularly scheduled meeting on March 3, 2021, voted, by a vote ¹of 41 in favor, 0 opposed, 0 abstaining, and 4 present but not eligible to vote, to (1) urge you to call for a working meeting of invited

stakeholders to address issues of public safety and community well-being which have arisen in the last year, predominantly in the Hell's Kitchen neighborhood, and to (2) express our appreciation for the related efforts of HKNC.

Based on testimony of dozens of local residents at both our committee and our full Board meetings from May 2020 to the present, many blocks in Hell's Kitchen have suffered a significant increase in public safety problems. For example, residents have reported physical attacks, being followed, aggressive verbal harassment and a noticeable uptick in public drug use and sales. We've heard from residents who no longer feel safe when leaving their homes to shop for groceries, attend medical appointments or for any other daily activities.

In October of 2020, many concerned residents organized, forming the Hell's Kitchen Neighborhood Coalition (HKNC), an organization of both new and established block associations, community organizations, business owners, and neighborhood residents. The coalition was formed by residents and local business owners to bring the local communities' needs to the attention of the City, and we appreciate their recent presentation to our HHHS Committee.

MCB4 is grateful for the assistance your offices have provided in the last year to address community issues, and now we urge you to organize a working meeting in March to address remaining public safety issues. Along with your offices and MCB4 representatives, we believe invitees should include representatives from the police precincts in our district (Midtown North, Midtown South, 13th, 10th, and Public Service Area 4), the NYC Department of Homeless Services, the Coalition for the Homeless, mental health experts, HKNC and any other subject-matter experts you believe would be helpful. This meeting will present an important opportunity to make real progress on the issues, to increase transparency in city government, and to rebuild trust and cooperation with the community and everyone affected.

Our neighbors need your assistance to continue to improve conditions in Community District Four, especially in the Hell's Kitchen neighborhood. Working together, we can ensure the safety and care of all people in the Hell's Kitchen community, including temporary and permanent residents, and people who are unsheltered. We look forward to continuing to partner with you on these important issues.
