315 W 46th Street New York, NY 10036 Application for On-Premises Retail License Statement for 500 Foot Hearing Manhattan Community Board 4

This statement is submitted to the Manhattan Community Board 4 in support of Harlem CD Inc.'s ("Claw Daddy's") application for an on-premises retail liquor license. Please see below.

**The Premises.** Claw Daddy's is a New Orleans style, Cajun seafood restaurant located in the Hells Kitchen neighborhood of Manhattan on 46<sup>th</sup> Street between 8<sup>th</sup> and 9<sup>th</sup> avenue (the "Premises"). Claw Daddy's is a minority owned business since opening its first location in the Lower East Side of Manhattan in 2012. The Premises consists of a cellar floor used for storage, a basement/ground floor with one customer bar, dining area and kitchen, and a first floor with one customer bar, dining area and small outdoor terrace. The Premises' seating arrangement consists of 139 indoor seats, including 24 bar seats.

Impact on the Community. As one of the few Cajun cuisine restaurants in New York City, Claw Daddy's serves as a driver of local tourism by bringing people from all parts of New York City to its tables, this in turn has helped other small businesses around them gain exposure and business they otherwise may not have had. Claw Daddy's continued success derives from its emphasis on workplace diversity. Its operations are led by women and people of color who live in the same communities they serve. This is one of the reasons Claw Daddy's was able to survive the COVID-19 pandemic; with local staff and a priority on their safety, health and compensation, Claw Daddy's was able to continue serving patrons and paying employees. With an emphasis on its food, Claw Daddy's atmosphere has been welcomed by the communities it currently serves, now Claw Daddy's is ready to bring that same diversity, delicious cuisine, and atmosphere to the Hell's Kitchen community.

**SLA Standard.** In determining whether the issuance of a liquor license would promote the "public convenience and advantage" and be in "public interest" the SLA considers:

- i) The number, classes, and character of licenses in proximity to the location and in the particular municipality;
- ii) Evidence that all necessary permits have been obtained from the state and all governing bodies;
- iii) The effect of granting the license on vehicular traffic and parking proximity to the location;
- iv) The existing noise level at the location and any increase in noise level that would be generated by the proposed premises;
- v) The history of liquor violations and reported criminal activity at the proposed premises; and
- vi) Any other factors specified by law or regulation that are relevant to determine the public convenience and advantage and public interest of the community.

Each of these factors will be addressed individually below.

i) Claw Daddy's address is 315 W 46th Street, New York, NY 10036. It is undisputed that there are more than three (3) on-premises establishments within 500 feet of the Premises as it sits in the area famously known as "Restaurant Row". However, while many food and beverage establishments have come and gone since the COVID-19 pandemic, Claw Daddy's was able to withstand the test of a lifetime and is now ready to serve the Chelsea, Clinton Hill and Hell's Kitchen communities with fun, delicious food, and drinks.

There are thirty-one (31) other active on-premises liquor licenses within 500 feet from the Premises. Approximately eight (8) of these on-premises liquor license establishments have relocated or permanently closed due to COVID-19 pandemic; below is the list:

After further investigation it appears that the following restaurants with on-premise licenses have closed: Scarlatto, Frankie & Johnnie's Steakhouse, Orso Restaurant, Don't Tell Mama NYC, Broadway Joe Steakhouse, Bourbon Street Bar & Grille, Al Hirschfeld Theater, and Margarita Bar NYC.

Approximately 116 feet away from the Premises there is a French Bistro named Le Rivage, with an on-premises license, which serves classic French fare. Approximately 171 feet away from the Premises there is a Jazz Club named Swing 46, with an on-premises license, which offers live music, swing dancing & free lessons. Approximately 186 feet away from the Premises there is a Bar named XOXO Bar NYC, with an on-premises license, which offers a variety of drinks and cocktails. Approximately 189 feet away from the Premises there is a Chinese Restaurant named Dim Sum Palace, with an on-premises license, which serves traditional Cantonese dishes and made to order Dim Sum. Approximately 223 feet away from the Premises there is an Italian Restaurant named Becco, with an on-premises license, which is famous for its innovative pasta tasting menu. Approximately 275 feet away from the Premises there is an Italian Restaurant named Lattanzi, with an onpremises license, which offers Roman-style pastas, meats and more. Approximately 276 feet away from the Premises there is a Cocktail Bar named Dutch Fred's, with an onpremises license, which serves craft beer and cocktails. Approximately 292 feet away from the Premises there is a Bar and Grill named The House of Brews, with an on-premises license, which serves a variety of craft beers. Approximately 298 feet away from the Premises there is a Bar named Beer Culture, with an on-premises license, which serves a variety of beers. Approximately 314 feet away from the Premises there is a Bar named BarDough, with an on-premises license, which offers customizable pizza, calzones, and cocktails. Approximately 325 feet away from the Premises there is a club named Flashdancers NYC, with an on-premises license, which offers cocktails and live entertainment. Approximately 328 feet away from the Premises there is an Irish Pub named Playwright Celtic Pub, with an on-premises license, which offers serving beers and pub food. Approximately 330 feet away from the Premises there is a Hamburger Restaurant named Bareburger, with an on-premises license, which serves organic burgers, beer, and wine. Approximately 344 feet away from the Premises there is a Bar named Ritz Bar and Lounge, with an on-premises license, which offers dancing with DJs, plus lounge rooms and an outdoor patio. Approximately 366 feet away from the Premises there is a Bar named Deacon Brodie's Tavern, with an on-premises license, which serves up cocktails & brews. Approximately 389 feet away from the Premises there is an Italian Restaurant named Daniela Trattoria, with an on-premises license, which serves authentic Italian cuisine. Approximately 407 feet away from the Premises there is a Japanese

Restaurant named Sake Bar Hagi 46, with an on-premises license, which is an eatery and sake bar offering yakitori, noodles. Approximately 418 feet away from the Premises there is a Ramen Restaurant named E.A.K. Ramen, with an on-premises license, which is a modern Japanese ramen shop specializing in house style noodles. Approximately 435 feet away from the Premises there is a Bar named Iron Bar and Lounge, with an on-premises license, which is a Gastropub serving craft beer on tap and gourmet bar bites. Approximately 449 feet away from the Premises there is an American Restaurant named Hold Fast Kitchen and Spirits, with an on-premises license, which serves creative pub fare with full bar and happy hour. Approximately 467 feet away from the Premises there is a Restaurant named Sushi Seki, with an on-premises license, which serves delicious sushi. Approximately 475 feet away from the Premises there is a Restaurant named Latitude Bar and Grill, with an on-premises license, which offers music, drinks, and lounge space.

Claw Daddy's will operate the Premises Monday-Thursday from 2pm to 10pm, and from Friday-Sunday it will operate from 12pm to 11pm. Claw Daddy's will indoor dining and take out. Claw Daddy's menu is being submitted with its application and shows that it is operating a true restaurant.

- ii) Claw Daddy's will begin its operations as soon as August 2021 and will maintain all applicable permits from government agencies.
- iii) Claw Daddy's community is home to a plethora of restaurants and is not oversaturated with bars and nightclubs. Accordingly, there will be no line of customers nor overcrowded outdoor drinking areas crowding the area surrounding the Premises; Claw Daddy's will primarily serve food. Further, there is no evidence of parking related incidents surrounding the Premises so there would be no notable impact on parking or traffic around the Premises.
- iv) The Premises currently does not have any outdoor dining areas.
- v) Since 2012, Claw Daddy's has operated its other locations with excellent records; no SLA violations or criminal activity reported. It is not reasonable to presume that the Premises will be operated differently with an on-premises liquor license. Claw Daddy's will do everything in its power to remain compliant with local authorities and the SLA.
- vi) Chelsea, Clinton Hill, and Hells Kitchen are very active and historic neighborhoods with many restaurants and shops as diverse as the people living there. The boutique shops are complemented by ethnic and trendy upscale eateries. Claw Daddy's application for an onpremise liquor license will not only compliment its current menu, but will also enhance the service Claw Daddy's will provide the New York City community, namely, Chelsea, Clinton Hill and Hell's Kitchen.

For all the aforementioned reasons, it is clear that the liquor license application of Claw Daddy's with respect to 315 W 46th Street is in the public interest, convenience and advantage of the community. Accordingly, we respectfully request that Manhattan Community Board 4 approve Claw Daddy's application for an on-premises liquor license.
